**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement (this "Release") is given as of July 27, 2011, by Bank of America, N.A., a National Banking Association, in its capacity as Administrative Agent, with an address of 231 South LaSalle Street, Chicago, Illinois 60697 (the "Agent") for the benefit of Integral Systems, Inc., a Maryland corporation, with an address of 6721 Columbia Gateway Drive, Columbia, Maryland 21046, and each of its subsidiaries, including Avtec Systems, Inc., a Virginia corporation, with an address of 10530 Rosehaven Street, Suite 300, Fairfax, Virginia 22030, Newpoint Technologies, Inc., a Delaware corporation, with an address of 8B Industrial Way, Salem, New Hampshire 03079, SAT Corporation, a California corporation, with an address of 931 Benecia Avenue, Sunnyvale, California 94085, and CVG, Incorporated, a Virginia corporation, with an address of 44901 Falcon Place, Suite 116, Sterling, Virginia 20166 (the "Debtors");

WHEREAS, Debtors have fully discharged and satisfied the obligations secured by the Security Agreement, dated as of March 5, 2010 ("Security Agreement"), and the Trademark Security Agreement, dated as of March 5, 2010 (the "Trademark Security Agreement"). The Trademark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 4167/Frame 0899, Reel 4167/Frame 0929, Reel 4167/Frame 0950, Reel 4167/Frame 0907, and Reel 4167/Frame 0915 against the trademarks attached hereto as Exhibit A (the "Trademark Collateral"); and

WHEREAS, Debtors have requested that the Agent release, and the Agent is willing to release, subject to the terms hereof, its security interest, and any other right, title and interest it may have in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Agent does hereby terminate and release any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the Trademark Security Agreement against the Trademark Collateral.
2. Agent agrees to take such further action as may be reasonably requested by Debtors, from time to time, at Debtors' expense, to effectuate and carry out the provision and intent of this Release.
3. Agent represents and warrants to Debtors that it has not conveyed, transferred, granted a security interest in, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to the Trademark Collateral under the Security Agreement to any party other than Debtors.
