**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of August 5, 2011, is made by Bank of America, N.A., as Administrative Agent ("Administrative Agent"), in favor of YouStart, Inc. ("YouStart") as follows:

WITNESSETH

WHEREAS, pursuant to the Security Agreement dated May 25, 2007 ("Security Interest"), the Notice of Grant of Security Interest in Trademarks, dated May 25, 2007 was recorded with The United States Patent and Trademark Office on August 3, 2007 at Reel/Frame No. 3594/0668, and YouStart granted Administrative Agent a continuing security interest in and continuing lien upon its trademarks and trademark applications (the "Trademark Collateral");

WHEREAS, YouStart has requested that Administrative Agent release its security interest in all right, title and interest of Administrative Agent in and to the trademark and all applications and registrations therefore, including goodwill, set forth in Schedule 1.

NOW, THEREFORE, Administrative Agent, without recourse, representation or warranty and at YouStart's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interests granted to Administrative Agent pursuant to the Security Interest in the trademark set forth in Schedule 1, attached hereto and incorporated herein by reference and the registrations of and applications for said trademark.

Administrative Agent agrees to provide YouStart with any information and additional authorization necessary to effect the release of Administrative Agent's security interest in the Trademark Collateral.
