TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made as of the 11th day of April, 2011, from STK, L.L.C. WHEREAS, Assignor represents and warrants that the Trademark is in force and effect as of the date of this Assignment and is free from any and all liens, claims, security interests or other encumbrances.

NOW, THEREFORE, in consideration of the premises and of the sum of one Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Assignor has sold, assigned and transferred and does hereby sell, assign and transfer unto Assignee, its successors and assigns, Assignor's entire right, title and interest in and to said Trademark, and in and to the goodwill of the business in connection with which said Trademark is used, and all rights and privileges pertaining to said Trademark, including all rights of recovery for past, present and future infringements thereof and for renewal of the registrations thereof for subsequent terms; the same to be held and enjoyed by Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by Assignor had this sale, assignment and transfer not been made.



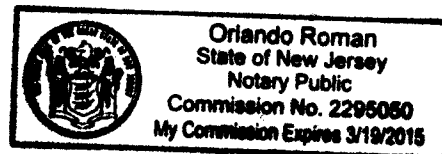
