**STATUTORY DECLARATION IN SUPPORT OF
CORRECTIVE ASSIGNMENT**

I, the undersigned, declare:

1. My name is Maurice S. Kanbar of Rex Games, Inc., located at 2100 Jackson Street, 1st Floor, San Francisco, California 94115 ("Rex Games"). I hold the position of President and CEO of Rex Games and have held that position since 2006.

2. I am also the Trustee of the Maurice S. Kanbar Revocable Trust U/T/A Dated June 7, 2001, with an address of 2100 Jackson Street, 1st Floor, San Francisco, California 94115 (the "Trust"). I have held the position of Trustee of the Trust since June 7, 2001.

3. I make this declaration in support of U.S. Registration No. 1,210,734 for the mark TANGOES, registered for "puzzles" in International Class 28 (the "TANGOES Registration").

4. I am authorized to make this declaration on behalf of Rex Games and the Trust. The facts and matters declared to in this declaration are within my knowledge or obtained from information contained in documents in the possession of Rex Games and/or the Trust, which information I believe to be true.

5. The TANGOES Registration was registered on September 29, 1982 to me, Maurice S. Kanbar, in my individual capacity.

6. On August 16, 1993, I assigned the TANGOES Registration to Rex Games. The assignment was recorded at Reel 1050, Frame 0321 on August 23, 1993 with the United States Patent and Trademark Office (the "USPTO").

7. On July 25, 2002, an "Assignment of Trademarks and Service Mark" was executed by me that erroneously assigned all right, title and interest in and to the TANGOES Registration from me as an individual to the Trust. This erroneous assignment was recorded with the USPTO at Reel 2557, Frame 0547 on August 6, 2002.

8. The erroneous assignment was prepared by counsel who was unaware that I had previously assigned the TANGOES Registration to Rex Games. Had my previous counsel known of the prior assignment of the TANGOES Registration to Rex Games, the erroneous assignment would not have been prepared, executed and recorded with the USPTO.

9. Since August 16, 1993, Rex Games has been and continues to be the true owner of the TANGOES Registration.

10. The ownership of the TANGOES Registration should not have been altered by the erroneous assignment recorded at Reel 2557, Frame 0547; the Trust has never held an ownership interest in the TANGOES Registration.


11. Rex Games and the Trust wish to correct the errors in the chain of title for the TANGOES Registration to reflect that Rex Games has been and continues to be the owner of the mark.

12. Rex Games hereby submits a corrective assignment cover sheet identifying Rex Games as the owner of the TANGOES Registration. Rex Games and the Trust request that the USPTO update the ownership information for the TANGOES Registration to reflect that Rex Games is and has been the owner of the mark since August 16, 1993.





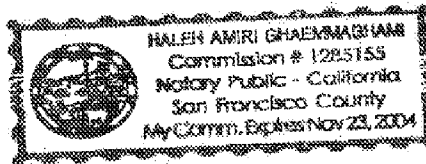
