TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("**Trademark Agreement**") is entered into as of April 19, 2010 (the "**Effective Date**") by and between Lifetree Technologies, LLC, a Delaware limited liability corporation, with a principal business address of 3500 Sunrise Highway, #T111, Great River, New York 11739 ("**Assignor**") and Galaxy Technology Corp., a New York corporation, with a principal business address of 5 Kew Court, Northpoint, New York 11768 ("**Assignee**").

WHEREAS, Assignor desires to transfer all right, title, and interest in and to the trademark, LIFETREE ICTM (Registration No. 2,960,052), all applications and registrations pertaining thereto and all common law rights associated therewith, together with all goodwill arising from the use of and symbolization by said trademark (the "**Trademark**").

NOW, THEREFORE, in consideration of their mutual interests and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby assigns, transfers, sells, conveys, and delivers to Assignee, its successors and assigns, all right, title and interest in and to the Trademark throughout the world, including without limitation the goodwill of the business appurtenant thereto and which is symbolized thereby, that portion of the business to which the Trademark pertain, including the right to license others under the Trademark and the right to renew any trademark registration which shall issue from the application included in the Trademark, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor had this assignment and sale not been made.
2. Assignor authorizes Assignee to record this agreement in the United States Patent & Trademark Office and in similar government offices throughout the world.
3. This Trademark Agreement shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of New York, without giving effect to the principles of conflicts of law.
