RELEASE OF SECURITY AGREEMENT

THIS RELEASE OF SECURITY AGREEMENT is made as of June 21, 2011, by CAPITAL BUSINESS CREDIT LLC, a Delaware limited liability company having an address of 1700 Broadway, New York, NY 10019, as secured party ("Secured Party"), for the benefit of Worldwide Dreams, LLC, a Delaware limited liability company, located at 350 Fifth Avenue, Suite 2101, New York, New York 10118, as debtor ("Debtor").


