TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of August 22, 2011, by and among Suzanne S. Langley and Joseph E. Langley (collectively, the "Assignor"), and Build-A-Bear Retail Management, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademark BUILD A BOW and the trademark application U.S. Ser. No. 77/157,503 (the "Mark");



WHEREAS, Assignor wishes to assign the entire rights, title and interest in and to the Mark and the goodwill associated with such Mark to Assignee and Assignee desires to assume such mark and the goodwill of the business related thereto.

NOW, THEREFORE, in consideration of one (1) dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:


1. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in and to the Mark and U.S. App. Ser. No. 77/157,503 together with the goodwill of the business associated therewith, and all causes of action, past, present and future for infringement of the Mark.
2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Mark in Assignee, its successors and assigns, and that it will, at any time upon request, communicate and provide to Assignee, its successors and assigns, such facts and documents relating to the Mark or the history thereof as may be known to it.
