Ladies and Gentlemen:

Reference is hereby made to the Trademark Security Agreement Supplement, dated as of September 30, 2004 (the "Trademark Security Agreement"), by and between Mitsubishi Motors North America, Inc., a California corporation (in such capacity, the "Grantor") and The Bank of Tokyo-Mitsubishi UFJ, Ltd. (formerly known as The Bank of Tokyo-Mitsubishi, Ltd.), New York Branch, a Japanese banking corporation ("BTMU"), in its capacity as the collateral agent (in such capacity, the "Collateral Agent") for the MMNA Secured Parties. Capitalized terms used but not defined herein shall have the meaning assigned in the Trademark Security Agreement.

Pursuant to the Letter Agreement, dated as of November 9, 2009 (the "Letter Agreement"), by and among BTMU, in both its capacity as collateral agent and MMNA Lender, the Grantor and other grantors identified on the signature pages of the Letter Agreement, the security interest in the Trademark Collateral has been terminated.

As such, effective contemporaneously to the signing and closing of the Letter Agreement and as confirmed by the parties hereto by their execution hereof, the Trademark Security Agreement and each and every provision thereof shall terminate and thereafter be of no further force and effect without any further liability or obligation on the part of the Grantor, other than the provisions therein which by their terms expressly are intended to survive termination.

By acceptance and acknowledgment below, the Collateral Agent hereby waives any other conditions required under the Trademark Security Agreement, including any requirement for prior written notice.
