ARTICLES OF CONVERSION
OF
INVISIBLE GADGET GUARD, LLC

The undersigned, Invisible Gadget Guard, LLC, a Utah limited liability company (the "Company"), acting pursuant to Section 16-10a-1008.7 of the Utah Revised Business Corporation Act, and Section 48-2c-1406 of the Utah Revised Limited Liability Company Act (the "LLC Act"), hereby adopts the following Articles of Conversion for the Company to convert to a Utah corporation:



ARTICLE I
DATE AND JURISDICTION OF ORGANIZATION

The Company was organized November 26, 2007 in the State of Utah.

ARTICLE II
NAME OF COMPANY PRIOR TO CONVERSION

The name of the Company prior to the filing of these Articles of Conversion was Invisible Gadget Guard, LLC.

ARTICLE III
NAME OF COMPANY FOLLOWING CONVERSION

The name of the Company as of the filing of these Articles of Conversion, and as set forth in its Articles of Incorporation filed with the Division of Corporations and Commercial Code (the "Division"), is Invisible Gadget Guard, Inc.

ARTICLE IV
EFFECTIVE DATE OF CONVERSION

The effective date of the conversion of the Company to a corporation shall be the date that these Articles of Conversion are filed with the Division.

ARTICLE V
APPROVAL OF CONVERSION

The conversion of the Company to a corporation has been duly approved by the unanimous written consent of the members of the Company as required by the LLC Act.

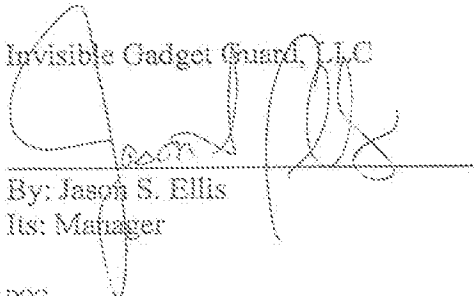
