RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the trademarks identified in Schedule A, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney granted by Grantor to Secured Party in the Security Agreement is terminated; and
3. authorizes Grantor or Grantor’s authorized representative to record this release with the United States Patent and Trademark Office.


