The Bank agrees to execute reasonable releases and other documents or agreements as the Company may reasonably request to confirm the release described above and to reflect such release of record.

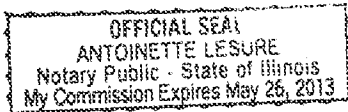
