TRADEMARK ASSIGNMENT

This Trademark Assignment is dated as of October 7, 2011 (the "Assignment") between the Trustee of the Chapter 7 estate of Tavern on the Green Limited Partnership, Jil Mazer-Marino, maintaining an office for the conduct of business at 990 Stewart Avenue, Suite 300, P.O. Box 9194, Garden City, New York, 11530-9194 (the "Assignor") and Tavern International LLC, a New Jersey limited liability company doing business at 8 Somerset Road, Tenafly, New Jersey 07670 (the "Assignee").

WHEREAS, Tavern on the Green Limited Partnership is a debtor in a case pending under chapter 7, title 11, United States Code in the United States Bankruptcy Court for the Southern District of New York, Case Number 09-15450 (ALG);

WHEREAS, Assignor is the owner of all right, title and interest in and to the U.S. Trademark Application Serial Number 85/063,715 for the trademark TAVERN ON THE GREEN for: (a) "holiday ornaments and wall decorations of common metal" in Class 6; (b) "silverware, namely, forks, knives, and spoons that are made of silver or silver-plated; boxes that are specially adapted for the storage of cutlery and flatware" in Class 8; (c) "lamps, lamp shades, lighting fixtures" in Class 11; (d) "kitchenware, namely, non-electric coffeemakers; dinnerware; bakeware; cookware, namely pots, pans, steamers, roasting pans; kitchen utensils, namely, kitchen tongs, splatter screens, pouring and straining spoons; bath accessories, namely, cup holders; holiday ornaments and wall decorations of glass, porcelain and china" in Class 21; (e) "bed, bath and table linens; curtains; towels" in Class 24; and (f) "christmas tree ornaments and decorations" in Class 28, including any and all goodwill of the business symbolized thereby (the "Mark");

WHEREAS, Assignor has agreed to transfer, sell and assign to Assignee, as a successor to the portion of the business to which the Mark pertains, all of Assignor's right, title and interest in and to the Mark; and

WHEREAS, Assignee desires to own all right, title and interest in and to the Mark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby conveys and assigns to Assignee all right, title and interest in and to the Mark, together with the right to receive and sue for all damages from past, present or future use and/or infringement of the Mark.
2. Further Assurances. Assignor agrees to execute and deliver at a future date any additional documents that are required to perfect Assignee's ownership of or title to the Mark.
3. Successor and Assigns. This Trademark Assignment is binding on the Assignor and its respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
