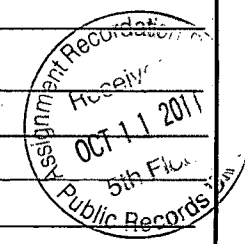

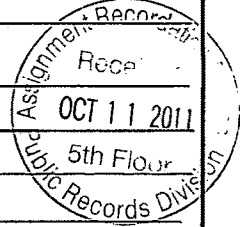

ASSIGNMENT OF SERVICEMARKS AND TRADEMARKS

RECITAL

Assignor, TF Egg Harbor Associates, LLC, TF Yachts, LLC and Assignee are parties to an Agreement dated as of the Effective Date (the "Agreement"), pursuant to which Assignor agreed to assign to Assignee and Assignee has agreed to accept from Assignor the Real and Intellectual Property Assets and Equipment (as defined in the Agreement), including without limitation the servicemarks, trademarks and trade names of Assignor.



Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Servicemarks and Trademarks shall be governed by and construed in accordance with the laws of the State of New Jersey without giving effect to the principles of conflicts of laws thereof.
