TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks set forth in Schedule A together with the goodwill symbolized by said Trademark(s), Application(s) and Registration(s) concurrent with the transfer of certain tangible assets as indicia of said goodwill.
