TRADEMARK AND SERVICE MARK ASSIGNMENT AGREEMENT

This TRADEMARK AND SERVICE MARK ASSIGNMENT AGREEMENT is made and entered into as of September 1, 2011 (the "Agreement"), by and between First American Professional Real Estate Services, Inc., a California corporation (the "Assignee"), GreenFolders, Inc., a Utah corporation ("Assignor").

Recitals

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated September 1, 2011 (as amended, the "Acquisition Agreement") under which Assignor assigned to Assignor all right, title and interest in, to and under the trademarks and service marks and applicable applications and registrations set forth on Schedule A (the "Assigned Trademarks").

WHEREAS, Assignee desires to confirm the assignment from the Assignor of all of the Assignor's right, title and interest in, to and under the Assigned Trademarks pertaining thereto; and

WHEREAS, Assignee is willing to accept such assignment on the terms and conditions set forth herein and in the Acquisition Agreement.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor hereby transfers and assigns to Assignee all of its right, title and interest, in, to and under the Assigned Trademarks, together with any and all renewals and extensions thereof under the laws of the United States or other jurisdictions, any goodwill associated with the Assigned Trademarks along with that portion of Seller's business in connection with which Seller had a bona fide intention to use any of the Assigned Trademarks and the right to sue both in equity and for damages occurring after the date hereof.

This Agreement is executed pursuant to the Acquisition Agreement and is entitled to the benefits and subject to the provisions thereof (including the representations, warranties and covenants, governing law, etc. contained therein) and shall be binding upon and inure to the benefit of the parties thereto and hereto and their respective successors and assignees. If there is a conflict, or in the event of any ambiguity between the terms of this Agreement and the Acquisition Agreement, the Acquisition Agreement shall govern.

This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same instrument.




