RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, OHIO MEDICAL CORPORATION, a Delaware corporation ("Borrower"), paid in full all obligations owing to GUGGENHEIM CORPORATE FUNDING, LLC, a Delaware Limited Liability Company ("Secured Party") pursuant to that certain Amended and Restated Trademark Security Agreement dated November 30, 2007; and

WHEREAS, by way of the Amended and Restated Trademark Security Agreement, Secured Party obtained a security interest in certain Trademark Collateral of Borrower, including the trademark registrations on Exhibit A hereto; and

WHEREAS, all liabilities and obligations owed by Borrower to Secured Party with respect to the aforementioned loan (other than contingent reimbursement obligations not yet due and payable) have been paid and satisfied in full, and all security interests, mortgages and other liens granted to or held by Secured Party for its benefit or as agent for the benefit of any other secured parties, including without limitation the security interest granted in the Amended and Restated Trademark Security Agreement dated November 30, 2007 ("Liens"), have been forever satisfied, released and discharged without further action.


NOW, THEREFORE, to the fullest extent permitted by law, Secured Party hereby releases and discharges all Liens on any of Borrower's right title and interest in and to all of the following: (i) all of its trademarks and trademark applications, including, without limitation, each trademark and trademark application listed on Schedule A hereto, and all renewals and extensions of the foregoing, (ii) all goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark application and (iii) all income, royalties and proceeds of the foregoing at any time due or payable or asserted under and with respect to the foregoing, including without limitation any claim by Grantor against third parties for damages by reason of past, present or future infringement of any trademark or trademark application, in each case together with the right to sue for and collect said damages. Secured Party shall promptly take such actions and execute and deliver such termination statements or other

documents as Borrower may from time to time reasonably request to effectuate, or reflect of public record, the release and discharge of the Liens.
