**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "**Agreement**") is dated as of December 1, 2011, by and among Gibson Guitar Corp., a Delaware corporation, having a usual place of business at 309 Plus Park Boulevard, Nashville, Tennessee 37217 ("**Purchaser**" and "**Assignee**"), and Stanton Magnetics, Inc., a Florida corporation, having a usual place of business at 772 S. Military Trail, Deerfield Beach, Florida 33442 (the "**Company**"), Cerwin-Vega, Inc., a Florida corporation and wholly owned subsidiary of the Company, having a usual place of business at 772 S. Military Trail, Deerfield Beach, Florida 33442 ("**CV**"), KRK Systems, LLC, a Florida limited liability company and wholly owned subsidiary of the Company, having a usual place of business at 772 S. Military Trail, Deerfield Beach, Florida 33442 ("**KRK**"), Stanton Europe, SPRL, a Belgian company, having a usual place of business at 382 Avenue de la Couronne, Brussels, Belgium ("**Stanton Europe**"), and Stanton Group Asia Pacific (Shanghai) Ltd., a Chinese wholly owned foreign invested enterprise, having a usual place of business at 20 Chaling Bei Road, Shanghai, China 20032 ("**Stanton Group Asia**"), and together with the Company, CV, KRK and Stanton Europe, the "**Sellers**"). All capitalized terms used herein but not otherwise defined shall have the meaning ascribed to them in the Asset Purchase Agreement (as defined below).

WHEREAS, Purchaser and Sellers are parties to the Asset Purchase Agreement, dated as of November 23, 2011 ("**Asset Purchase Agreement**"), pursuant to which each of the Sellers agreed to sell, transfer, assign, convey and deliver to Purchaser or one or more Affiliates of Purchaser designated by Purchaser, free and clear of all Encumbrances, all rights, title and interest in and to all of the Purchased Assets;

WHEREAS, certain of the Purchased Assets constitute Intellectual Property owned by Sellers used in connection with the Business ("**Assigned Intellectual Property**"), including the Intellectual Property set forth on Exhibit A hereto, which constitute the transfer of all or substantially all of the assets of a going business;

WHEREAS, Sellers own all rights, title and interest in and to the Owned Intellectual Property;

WHEREAS, Purchaser hereby designates Gibson Guitar Corp. as the Assignee;

WHEREAS, each Seller desires to sell, transfer, assign, convey and deliver to Assignee all of such Seller's rights, title and interest in and to the Assigned Intellectual Property owned or licensed, as applicable, by such Seller, and Assignee desires to purchase and acquire all such Assigned Intellectual Property; and

WHEREAS, the execution and delivery of this Agreement is a condition to Closing under the Asset Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of Sellers, Purchaser and Assignee hereby agrees as follows:

1. Assignment. Each of Sellers hereby sells, transfers, assigns, conveys and delivers to Assignee and its successors, assigns, and legal representatives, such Seller's entire rights, title and interest in and throughout the world in and to:

(a) the Assigned Intellectual Property, including (A) any common law rights that may exist and are associated therewith, (B) all rights to use, exploit, license and otherwise dispose of the same, and (C) the right to secure and renew any and all registrations thereof;

(b) all provisionals, non-provisionals, divisionals, continuations, continuations-in-part, substitutes, renewals, reissues, reexaminations, extensions, and all other applications which have been or shall be filed in the United States and all other countries in respect of the Assigned Intellectual Property or any improvements or derivatives thereof, specifically including the right to file such applications under the provisions of any convention or treaty and claim priority based on such application in the United States;

(c) all original, renewal, extension and reissued registrations which have been or shall be issued in the United States and all other countries in respect of the Assigned Intellectual Property and any improvements or derivatives thereof;

(d) all inventions and the patents as may issue or claim priority under United States law or international convention in respect of the Assigned Intellectual Property;

(e) all rights of priority and claims for damages for reason of past or current infringement, unauthorized use or misappropriation of the Assigned Intellectual Property, as well as the right to sue for and collect the same for Assignee's own use and enjoyment; and

(f) with respect to any and all trademarks, service marks or trade names, the goodwill of the business associated therewith and appurtenant thereto, including the right of filing additional arguments on all pending oppositions made by the Sellers on the basis of the trademarks against trademark applications filed by third parties. Where there are intent to use applications which can be converted to use-based applications, Seller shall promptly convert such applications and assign the same to Purchaser.

2. Authorization. Sellers shall release and transfer possession and control of the Internet domain name registrations included in the Assigned Intellectual Property ("**Domains**") by initiating the transfer with the current registrar of each Domain and using commercially reasonable efforts to perform, follow or cooperate with Assignee on all procedures and actions specified by each registrar. Sellers hereby authorize each such registrar to transfer the ownership, registration and control of the Domains to Assignee.

3. Severability. Each of Sellers, Purchaser and Assignee agrees that multiple copies of this Agreement may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Sellers, Purchaser and Assignee. This Agreement will be binding on the successors of Sellers and extend to the successors, assigns and nominees of Assignee.

4. Further Assurances. Sellers, from time to time after the Closing Date, at Purchaser's or Assignee's reasonable request, will execute, acknowledge, and deliver to Purchaser or Assignee such other instruments of conveyance and transfer and will take such other actions and execute and deliver such other documents, certifications, and further assurances as Purchaser or Assignee may reasonably request in order to evidence the transfers and assignments contemplated by this Agreement and to vest more effectively in Assignee, or to put Purchaser or Assignee more fully in possession of, any of the Assigned Intellectual Property. Each Seller will cooperate with Purchaser or Assignee and shall use commercially reasonable efforts to execute and deliver to Purchaser or Assignee such other instruments and documents and take such other actions, as may be reasonably requested from time to time by Purchaser or Assignee as reasonably necessary to carry out, evidence, and confirm the intended purposes of this Agreement.

5. Terms of the Asset Purchase Agreement. This Agreement is delivered pursuant to the terms of the Asset Purchase Agreement and confirms the conveyance of the Purchased Assets pursuant to the Asset Purchase Agreement. This Agreement supplements the Asset Purchase Agreement and shall not be construed to limit the terms thereof, which remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

6. Miscellaneous.

(a) Governing Law; Jurisdiction; Venue. This Agreement shall be construed under and governed by the internal laws of the State of New York without regard to its conflict of laws provisions. Any dispute arising out of or relating to this Agreement shall be resolved in accordance with Section 12.2 of the Asset Purchase Agreement.

(b) Entire Agreement. This Agreement, together with the Asset Purchase Agreement and the documents attached as exhibits thereto (collectively, the “*Transaction Documents*”), sets forth the entire understanding of the parties with respect to the subject matter of the Transaction Documents, and supersedes all prior contracts, agreements, arrangements, communications, discussions, representations and warranties, whether oral or written, between the parties to the Transaction Documents with respect to the subject matter thereof.

(c) Assignability; Binding Effect. Neither this Agreement nor any of the rights or obligations of Sellers, Purchaser or Assignee hereunder may be assigned by such party without the prior written agreement of the other parties; provided, however, that, (i) in the event of a Dissolution of any Seller, such Seller shall assign its rights and obligations under this Agreement to the Seller Representative without the consent of Assignee and (ii) each of Purchaser and Assignee may assign its rights and obligations under this Agreement to its subsidiaries without the consent of Sellers, provided that upon such assignment, Purchaser shall remain liable for all of its and Assignee’s obligations under this Agreement. This Agreement shall be binding upon Sellers and their respective successors and permitted assigns (if any), and Purchaser and Assignee and its successors and permitted assigns (if any). This Agreement shall inure to the benefit of the parties hereto. This Agreement shall not confer any rights or remedies upon any Person other than the parties hereto and their respective successors and permitted assigns.


(d) Captions and Gender. The captions in this Agreement are for convenience only and shall not affect the construction or interpretation of any term or provision hereof. The use in this Agreement of the masculine pronoun in reference to a party hereto shall be deemed to include the feminine or neuter, as the context may require.
