This assignment includes all of the ASSIGNOR's rights to register, enforce and sue for, and to receive monetary damages and equitable relief for, infringements of the Trademarks, including any which occurred prior to the date of this assignment and those that occur in the future.

ASSIGNOR retains no ownership rights in the Trademarks, trademark application or registration or any other rights transferred to ASSIGNEE by this assignment.


