RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of this 4th day of October, 2011 (“Effective Date”) by **ABLECO FINANCE LLC**, a Delaware limited liability company (“Ableco”), in its capacity as collateral agent for the Lender Group (together with its successors, and assigns, if any, in such capacity, “Collateral Agent”), in favor of **ENDURANCE INTERNATIONAL GROUP HOLDINGS, LLC**, a Delaware limited liability company, **THE ENDURANCE INTERNATIONAL GROUP, INC.**, a Delaware corporation, as successor by merger to Dot5Hosting, Inc., a California corporation, and StartLogic, Inc., an Arizona corporation, **EIG INVESTORS CORP.**, a Delaware corporation, **SIMPLESCRIPTS, INC.**, a Delaware corporation, f/k/a Caird Corporation, a Delaware corporation, **DOMAIN NAME HOLDING COMPANY, INC.**, a Delaware corporation, and **IPOWER, INC.**, an Arizona corporation (collectively, jointly and severally, “Grantors” and each individually “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and Collateral Agent dated October 10, 2008 (the “Trademark Security Agreement”; capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement), each Grantor granted to Collateral Agent a continuing first priority security interest in all of such Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “Trademark Collateral”):

- (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I hereto;
- (b) all goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (d) all products and proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under and Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License;

WHEREAS, Grantors and Collateral Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantors and Collateral Agent dated October 10, 2008 (the “Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) (i) on October 10, 2008, at Reel 003869, Frame 0220; (ii) on February 9, 2009, at Reel 003932, Frame 0183; (iii) on February 9, 2009 at Reel 003932, Frame 0203; (iv) on April 21, 2009, at Reel 003973, Frame 0457; (v) October 30, 2009, at Reel 004088, Frame 0413; and (vi) on December 23, 2010 at Reel 004440, Frame 0505;

WHEREAS, Grantors have paid all of their outstanding indebtedness to Collateral Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

Collateral Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than the Trademark Collateral set forth on Schedule I hereto, in any jurisdiction throughout the world.

Collateral Agent shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
