RELEASE OF TRADEMARK AND PATENT SECURITY INTERESTS

(ii) Each patent, patent registration and patent application listed on Schedule A hereto (including all reissues, continuations and extensions thereof), and all of the goodwill of the business connected with the use of, and symbolized by, each such patent, patent registration and patent application; and

(iii) All proceeds of the foregoing, including without limitation any claim by Grantors against third parties for damages by reason of past, present or future infringement or dilution of any trademark, patent, trademark registration, patent registration, trademark application or patent application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, patent, trademark registration, patent registration, trademark application or patent application, in each case together with the right to sue for and collect said damages.

The Grantee hereby represents and warrants to the Grantors that it has not, directly or indirectly, by operation of law or otherwise, assigned, transferred or conveyed any of its rights or obligations with respect to the Agreement or any trademark, patent, trademark registration, patent registration, trademark application or patent application listed on Schedule A hereto.
