RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") is made as of December 6, 2011 by CITICORP NORTH AMERICA, INC. ("**Citicorp**") in favor of FAIRMONT HOTELS & RESORTS (U.S.) INC., FAIRMONT HOTELS INC., FAIRMONT SPAS INC., CP HOTELS (U.S.) 1998 INC., CHATEAU LAKE LOUISE CORP., FHR REAL ESTATE CORPORATION, COPLEY PLAZA 2001 LLC, DELTA HOTELS LTD., and FHR (ML) HOTEL HOLDINGS LLC (hereinafter, collectively the "**Grantors**").

WHEREAS, a security interest was recorded by Citicorp with the United States Patent and Trademark Office on May 12, 2006, at Reel 003307, Frame 0640 with respect to certain U.S. trademark registrations and trademark applications, including the trademarks listed on Schedule A hereto (such trademarks, the "**Released Trademarks**"); and

WHEREAS, the Grantors have requested that Citicorp release, and Citicorp has agreed to release, all of its right, title and interest in and to the Released Trademarks and to discharge any obligations of the Grantors in respect of the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Citicorp hereby agrees as follows:

SECTION 1. Release of Security Interest. Citicorp does hereby release and discharge, without recourse, representation or warranty of any kind, all of Citicorp's right, title and interest in and to the Released Trademarks.


SECTION 2. Recordation. Citicorp authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.

SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York without regards to conflicts of laws principles.
