

APPROVAL AND VESTING ORDER

THIS MOTION, made by James Williams & Associates Inc., in its capacity as the Court-appointed Receiver (the "Receiver") of all of the assets, undertakings and properties of Dreamcatcher Interactive Inc. (the "Debtor") for an order approving the sale transaction (the "Transaction") contemplated by the purchase and sale agreement (as amended, the "Sale Agreement") dated as of October 14, 2011 between the Receiver and Go-Game Outlet Aktiebolag (the "Purchaser") and vesting in the Purchaser, the Debtor's right, title, and interest in and to the Purchased Assets (as defined in the Sale Agreement), was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Third Report of the Receiver dated October 19, 2011, and on hearing the submissions of counsel for the Receiver and the Purchaser, no one appearing for any other

person on the service list, although properly served as appears from the Affidavit of Sherine Burke affirmed on October 25, 2011, filed;

- 1. **THIS COURT ORDERS AND DECLARES** that this motion is properly returnable this day, that service on those persons already served shall be and is hereby validated, and that no further service of the motion record shall be required.
- 2. THIS COURT ORDERS THAT capitalized terms used but not defined in this Order shall have the meaning ascribed thereto in the Sale Agreement.
- 3. **THIS COURT ORDERS THAT** in the event of an assignment of the Purchaser's rights and benefits under the Sale Agreement, the term "Purchaser" shall mean the assignee.
- 4. THIS COURT ORDERS AND DECLARES that the Transaction is hereby approved, and that the Sale Agreement, including the Purchase Price provided for therein, is commercially reasonable and in the best interests of the Debtor and its creditors. The execution of the Sale Agreement by the Receiver is hereby authorized and approved, with such amendments as the Receiver may deem necessary. The Receiver is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable for the completion of the Transaction and for the conveyance of the Purchased Assets to the Purchaser.
- 5. THIS COURT ORDERS AND DECLARES that upon the delivery of a Receiver's certificate to the Purchaser substantially in the form attached as Schedule "A" hereto (the "Receiver's Certificate"), all of the Debtor's right, title, and interest in and to the Purchased Assets described in the Sale Agreement (including, without limitation, those Purchased Assets listed on Schedule "B" hereto) shall vest absolutely in the Purchaser, free and clear of, and from any and all security interests (whether contractual, statutory, or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory, or otherwise), liens, executions, levys, charges, or other financial, proprietary or monetary claims, adverse claims or rights of use, whether or not they have attached or been perfected, registered or filed and whether

secured, unsecured, legal, equitable, possessory or otherwise (collectively, the "Claims") including, without limiting the generality of the foregoing:

- (a) any encumbrances or charges created by the Order of this Honourable Court dated May 20, 2011;
- (b) all charges, security interests or claims evidenced by registrations pursuant to the Personal Property Security Act (Ontario) or any other personal property registry system; and
- (c) without limiting the foregoing, those Claims listed on Schedule "C" hereto,

(all of which are collectively referred to as the "Encumbrances"), and, for greater certainty, this Court orders that all of the Claims and Encumbrances affecting or relating to the Purchased Assets are hereby expunged and discharged as against the Purchased Assets.

- 6. THIS COURT ORDERS that for the purposes of determining the nature and priority of Claims, the net proceeds from the sale of the Purchased Assets shall stand in the place and stead of the Purchased Assets, and that from and after delivery of the Receiver's Certificate, all Claims and Encumbrances shall attach to the net proceeds from the sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale, as if the Purchased Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale.
- 7. **THIS COURT ORDERS AND DIRECTS** the Receiver to file with the Court a copy of the Receiver's Certificate, forthwith after delivery to the Purchaser thereof.
- 8. THIS COURT ORDERS that, pursuant to clause 7(3)(c) of the Canada *Personal Information Protection and Electronic Documents Act*, the Receiver is authorized and permitted, but not obligated, to disclose and transfer to the Purchaser all human resources and payroll information in the Debtor's records pertaining to the Debtor's past and current employees. The Purchaser shall maintain and protect the privacy of such information and shall be entitled to use

the personal information provided to it in a manner which is in all material respects identical to the prior use of such information by the Debtor.

9. THIS COURT ORDERS that notwithstanding:

- (a) the pendency of these proceedings;
- (b) any applications for a bankruptcy order now or hereafter issued pursuant to the Bankruptcy and Insolvency Act (Canada) in respect of the Debtor and any bankruptcy order issued pursuant to any such applications; and
- (c) any assignment in bankruptcy made in respect of the Debtor,

the vesting of the Purchased Assets in the Purchaser pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtor and shall not be void or voidable by creditors of the Debtor, nor shall it constitute or be deemed to be a transfer at under value, fraudulent preference, assignment, fraudulent conveyance or other reviewable transaction under the *Bankruptcy and Insolvency Act* (Canada) or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

- 10. THIS COURT ORDERS AND DECLARES that neither the *Bulk Sales Act* (Ontario), Sections 6(1) and (2) of the *Retail Sales Tax Act* (Ontario) nor any similar or equivalent legislation under any province or territory in Canada applies to the Transaction.
- 11. THIS COURT HEREBY REQUESTS the aid and recognition of any Court, tribunal, regulatory or administrative body having jurisdiction in Canada or elsewhere to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in

carrying out the terms of this Order.
