TERMINATION OF TRADEMARK SECURITY INTEREST

This TERMINATION OF TRADEMARK SECURITY INTEREST, dated as of December 13, 2011, (the "Termination") is among THE BANK OF NEW YORK MELLON, in its capacity as the collateral agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Collateral Agent"), and GACCF, LLC, a Delaware limited liability company, PMF, LLC, a Delaware limited liability company, PTF, LLC, a Delaware limited liability company, TCBY SYSTEMS, LLC, a Delaware limited liability company, and THE MRS. FIELDS' BRAND, INC., a Delaware corporation (individually, a "Pledgor", and, collectively, the "Pledgors"), as follows:

WITNESSETH

WHEREAS, in connection with (1) the Credit and Guaranty Agreement, dated as of October 24, 2008 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Existing Credit Agreement"), by and among Mrs. Fields Famous Brands, LLC, a Delaware limited liability company (the "Company"), each subsidiary of the company (including the Pledgors), the lenders party thereto and The Bank of New York Mellon, in its capacity as administrative agent and as collateral agent and (2) the Security Agreement, dated as of October 24, 2008, by and among the Company and each subsidiary of the Company (including the Pledgors) in favor of the Collateral Agent, the Pledgors executed and delivered the Trademark Security Agreement (defined below);

WHEREAS, the Trademark Security Agreement, dated as of October 24, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") between the Pledgors and the Collateral Agent was recorded with the United States Patent and Trademark Office on October 24, 2008 at Reel/Frame No. 3880/0125 in favor of the Collateral Agent;

WHEREAS, pursuant to the Trademark Security Agreement, to secure the prompt payment and performance of the Secured Obligations, each of the Pledgors granted to the Collateral Agent, for the benefit of itself and Lenders, a continuing security interest in all of such Pledgor's right, title and interest in and to the following property, whether then existing or thereafter acquired or arising and whether registered or unregistered (collectively, the "Trademark Collateral"): (i) all state (including common law) and federal trademarks, service marks and trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, together with and including all licenses therefor held by such Debtor, and all registrations and recordings thereof, and all applications filed or to be filed in connection therewith, including registrations and applications in the PTO, any State of the United States (but excluding each application to register any trademark, service mark, or other mark prior to the filing under applicable law of a verified statement of use (or the equivalent) for such trademark or service mark) and all extensions or renewals thereof, including without limitation any of the foregoing identified on the Schedule I through Schedule V attached hereto which lists the name of, and relates to, such Debtor (as the same may be amended, modified or supplemented from time to time), and the right (but not the obligation) to register claims under any state or federal trademark law or regulation and to apply for, renew and extend any of the same, to sue or bring

opposition or cancellation proceedings in such Debtor's name or in the name of the Collateral Agent for past, present or future infringement or unconsented use thereof, and all rights arising therefrom throughout the world (collectively, the "Trademarks"); (ii) all claims, causes of action and rights to sue for past, present or future infringement or unconsented use of any Trademarks of such Debtor and all rights arising therefrom and pertaining thereto; (iii) all general intangibles related to or arising out of any of the Trademarks and all the goodwill of such Debtor's business symbolized by the Trademarks or associated therewith; and (iv) all Proceeds of any and all of the foregoing;

WHEREAS, the Obligations under and as defined in the Existing Credit Agreement are being refinanced (the "Refinancing") with the proceeds of that certain Credit and Guaranty Agreement (as amended, restated, supplemented, extended or otherwise modified from time to time, the "New Credit Agreement"), dated as of December [13], 2011, by and among the Company, Mrs. Fields Financing Company, Inc. ("MFFC" together, the Company, the "Borrowers"), the Guarantors party thereto, each lender from time to time party thereto, and The Bank of New York Mellon as administrative agent and collateral agent;

WHEREAS, in connection with the Refinancing, the Collateral Agent acknowledges payment and performance in full of the Secured Obligations, and has released its security interest on any property of the Pledgors in favor of the Collateral Agent (the "Collateral Release") securing the Obligations (under and as defined in the Existing Credit Agreement), including, without limitation, all security interests in each of the Pledgors' right, title and interest in and to the Trademark Collateral, including, without limitation, pursuant to the Trademark Security Agreement;

WHEREAS, in connection with such Collateral Release, the Pledgors have requested that the Collateral Agent release its security interest in the Trademark Collateral and terminate the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without recourse, representation or warranty hereby (i) TERMINATES and RELEASES, with respect to each Pledgor, all of its right, title and interest in and to the security interest in all of such Pledgor's Trademark Collateral, (ii) re-assigns to such Pledgor any and all right, title or interest in may have in such Trademark Collateral, and (ii) agrees, confirms and acknowledges that the Trademark Security Agreement is hereby terminated. In addition, the Collateral Agent agrees, at the Pledgors' sole cost and expense, to provide the Pledgors with further information and additional authorization reasonably necessary to evidence such release as may be reasonably requested by the Pledgors.

Capitalized terms used and not defined herein having the meaning assigned to such terms in the Existing Credit Agreement.
