TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 23, 2011, is made by BMO Harris Financing, Inc., a Delaware corporation, and Bank of Montreal, a Canadian chartered bank (collectively, the "*Secured Party*").


WHEREAS, the Secured Party has agreed to terminate and release its security interest in such Trademark Collateral;
