**SECOND AMENDMENT TO SECURITY AGREEMENT**

THIS SECOND AMENDMENT TO SECURITY AGREEMENT ("Amendment") dated as of December 20, 2011, is by and among GLOBAL SAFETY LABS, INC., a Delaware corporation ("Debtor"), MICHAEL L. THIELE and ELAINE THIELE, THE W. KENT DUNBAR 1994 TRUST DATED NOVEMBER 2, 1994 and THE LARRY J. BUMP TRUST DATED 4/24/91 (collectively, the "Secured Parties").

**RECITALS:**

A. Debtor and Secured Parties are parties to that certain Security Agreement dated as of December 14, 2010, as amended by First Amendment to Security Agreement dated as of June 30, 2011 (as amended, the "Security Agreement").

B. Debtor and Secured Parties desire to further amend the Security Agreement as provided herein.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained herein, the parties hereto, intending to be legally bound, agree as follows:

1. Recitals. The recitals set forth hereinabove are hereby incorporated herein by this reference with the same force and effect as if fully hereinafter set forth.

2. Amendment. The Security Agreement is hereby amended by redefining the term "Notes" contained in Recital A as follows:

"The term "Notes" as used herein shall mean: (a) that certain Second Amended and Restated Master Promissory Note dated December 20, 2011 in the principal amount of up to SIX MILLION AND NO/100 DOLLARS (\$6,000,00.00) made by Debtor and payable to the order of the Larry J. Bump Trust dated 4/24/91, (b) that certain Second Amended and Restated Master Promissory Note dated December 20, 2011 in the principal amount of up to SIX MILLION AND NO/100 DOLLARS (\$6,000,000.00) made by Debtor and payable to the order of Michael L. Thiele and Elaine Thiele, and (c) that certain Master Promissory Note dated December 3, 2010 in the principal amount of up to THREE MILLION AND NO/100 DOLLARS (\$3,000,000.00) made by Debtor and payable to the order of the Kent W. Dunbar 1994 Trust dated November 2, 1994."


3. Effect of Amendment. Except as specifically amended hereby, the Security Agreement shall continue in full force and effect.
