**ARTICLES OF MERGER
OF**

SIGNAL INVESTMENT & MANAGEMENT CO.
(a Delaware corporation)

WITH AND INTO

CHATTEM INC.
(a Tennessee corporation)

To the Secretary of State
State of Tennessee

Pursuant to the provisions of the Tennessee Business Corporation Act governing the merger of a foreign wholly-owned subsidiary business corporation into its domestic parent business corporation, the domestic parent business corporation hereinafter named does hereby submit the following articles of merger.

1. The name of the subsidiary corporation, which is a business corporation organized under the laws of the State of Delaware, is Signal Investment & Management Co. ("Signal").

2. The name of the parent corporation, which is a business corporation organized under the laws of the State of Tennessee, and which is subject to the provisions of the Tennessee Business Corporation Act, is Chattem Inc. ("Chattem")

3. The number of outstanding shares of Signal is two thousand (2,000) all of which are owned by Chattem Inc.

4. The following is the Plan of Merger for merging Signal into Chattem as approved by resolution of the Board of Directors of Chattem on November 15, 2011. Approval by the shareholders was not required.

"1. Chattem, which is a business corporation of the State of Tennessee and is the parent corporation and the owner of all of the outstanding shares of Signal which is a business corporation of the State of Delaware and the subsidiary corporation, hereby merges Signal into Chattem pursuant to the provisions of the Tennessee Business Corporation Act and pursuant to the provisions of the laws of the jurisdiction of organization of Signal.

"2. The separate existence of Signal shall cease at the effective time and date of the merger pursuant to the provisions of the laws of the jurisdiction of its organization; and Chatterm shall continue its existence as the surviving corporation pursuant to the provisions of the Tennessee Business Corporation Act.

"3. The issued shares of Signal shall not be converted in any manner, but each said share which is issued as of the effective date of the merger shall be surrendered and extinguished.

"4. The Board of Directors and the proper officers of Chatterm are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for."

5. Chatterm is the owner of all of the issued shares of Signal, and Chatterm waived the mailing of a copy of the Plan of Merger.

6. The laws of the jurisdiction of organization of Signal permits a merger of a wholly-owned subsidiary business corporation of that jurisdiction into a parent business corporation of the State of Tennessee; and the merger of Signal into Chatterm is in compliance with the laws of the jurisdiction of organization of Signal.

7. The effective time and date of the merger herein provided for in the State of Tennessee shall upon filing.
