TRADEMARK COLLATERAL AGREEMENT

This 30th day of September, 2011, Marketwire, Inc. ("*Debtor*") with its mailing address at 25 York Street, Suite 900, P.O. Box 403, Toronto, ON M5J 2V5 in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, assigns, mortgages and pledges to Bank of Montreal, as administrative agent (the "*Agent*") with its mailing address at Agent Bank Services, 4th Floor, First Canadian Place, Toronto, Ontario, M5X 1A1 on behalf of itself and other persons as may be lenders from time to time (the "*Lenders*") and grants to the Agent for the benefit of the Lenders a continuing security interest in, the following property:

(i) Each trademark and trademark application listed on Schedule A hereto and all of the words, phrases, logos, servicemarks, or other graphical symbols claimed therein and any and all reissues, continuations, continuations-in-part or extensions thereof; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark application listed on Schedule A hereto, in each case together with the right to sue for and collect said damages;

to secure the payment and performance of all obligations, present and future, direct and indirect of the Debtor to the Lenders arising under an amended and restated credit agreement among the Debtor, Marketwire L.P., Marketwire Canada Limited, MW Holdco (2006) Inc., the Agent and Lenders dated August 31, 2011, as such credit agreement may be amended or amended and restated from time to time (the "*Credit Agreement*").


Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the assignment, mortgage, pledge and security interest in the trademarks and trademark applications made and granted hereby are more fully set forth in the security agreements delivered by the Debtor in favour of the Agent and Lenders in connection with the Credit Agreement.


THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


