**TRADEMARK QUITCLAIM ASSIGNMENT AND DISCLAIMER**

WHEREAS, Cycle Country Accessories Corp. a Nevada corporation, and Cycle Country Accessories Corporation, an Iowa corporation (collectively, "Cycle Country"), purported to assign all right, title, and interest in U.S. Trademark Reg. No. 2,536,627 for PERF.FORM (the "Trademark"), including all common law rights and the goodwill associated therewith, to Kolpin Outdoors, Inc. ("Kolpin") via an assignment executed on December 31, 2011, and recorded on January 24, 2012, at Reel 4704, Frame 0096, in the U.S. Patent and Trademark Office (the "Kolpin Assignment");

WHEREAS, Cycle Country Accessories Corporation, a Nevada corporation, had previously assigned all right, title, and interest in the Trademark to Perf-Form Products Incorporated, a South Dakota corporation having a place of business at 10527 Moller Road, Spearfish, South Dakota 57783 ("Perf-Form"), via an assignment executed on December 7, 2011, and recorded on December 29, 2011, at Reel 4689, Frame 0183, in the U.S. Patent and Trademark Office (the "Perf-Form Assignment"); and

WHEREAS, the Kolpin Assignment was made and recorded in error and Kolpin wishes to acknowledge that it has no rights in or to the Trademark and to assign to Perf-Form any rights in the Trademark that it may have acquired, including in any applications and registrations therefor, and together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, along with the right to recover damages and profits for past and future infringements thereof.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, Kolpin hereby disclaims any interest whatsoever in the Trademark and does hereby sell, assign, and transfer unto Perf-Form any right, title, or interest it may have in and to the Trademark and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof.
