## ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment (“Assignment”) is made effective as of December 21, 2010 from **FISHER INDUSTRIES, INC.** (“ASSIGNOR”), to **PRODUCTS FABRICATION, INC.** (“ASSIGNEE”):

WHEREAS, ASSIGNOR is the owner of the trademark (the “Mark”) registered in the United States Patent and Trademark Office under U.S. Trademark Registration No. 2466331 on July 3, 2001 for the Mark: FisherPump, together with the goodwill of the business symbolized thereby in connection with the goods on which the Mark is used (the “Product”).

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Mark.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR’s right, title, and interest of whatever kind in and to the Mark, together with (1) the goodwill of the business relating to the Product in respect upon which the Mark is used and for which they are registered, (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages and payment for past or future infringements and misappropriations of the Mark, and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark.
