NUNC PRO TUNC ASSIGNMENT

THIS **NUNC PRO TUNC ASSIGNMENT** is effective as of February 22, 2011, by Hartstone, LLC, a limited liability company then organized under the laws of the Commonwealth of Kentucky (“Assignor” or “the Business”), and between Hartstone, Inc., a corporation currently organized under the laws of the Commonwealth of Kentucky, with a business address of P.O. Box 30, Glenview, Kentucky 40025 (“Assignee”).

WITNESSETH:

WHEREAS, Assignor was the owner of all right, title and interest in and to the trademark HARTSTONE (hereinafter referred to as “the Mark”), and the corresponding registration therefor with the United States Patent & Trademark Office (“USPTO”), namely, Reg. No. 3,069,516 (hereinafter referred to as “the Registration”), and continued to use the Mark and Registration in commerce during all pertinent times;

WHEREAS, the undersigned, Ronald A. McLeod, pursuant to KRS 275.300 is authorized to execute this Nunc Pro Tunc Assignment of the Mark and Registration as Manager of Hartstone, LLC, as part and parcel of the winding down of the business of Hartstone, LLC, which was dissolved as of January 1, 2011;

NOW, THEREFORE, in consideration of One Dollar (U.S. \$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby transfer and assign, and evidence its assignment unto Assignee of:

1. all of Assignor’s entire and exclusive right, title and interest in and to the Mark and Registration, together with the goodwill of the business connected with the use of and symbolized by the Mark and Registration, including the right to register the Mark in Assignee’s name throughout the world; and

2. the sole right to enforce rights in the Mark and Registration, and all rights of priority and protection of interests therein under the laws of any jurisdiction worldwide based on the Mark and Registration, including the right to sue for and recover for Assignee’s own use accrued profits or damages for any and all causes of action, claims, and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.
