**ORDER AUTHORIZING SALE OF SUBSTANTIALLY ALL OF THE
ASSETS OF THE BRYANT DEBTORS FREE AND CLEAR OF ALL
LIENS, CLAIMS, INTERESTS AND ENCUMBRANCES PURSUANT TO
SECTIONS 363(b), (f) AND (m) OF THE BANKRUPTCY CODE**

Upon the amended motion (the "Amended Sale Motion")¹ of Bryant Grinder Corporation ("Bryant"), J&L Metrology Company ("J&L", together with Bryant, the "Bryant Debtors"), Fellows Corporation ("Fellows"), and Jones & Lamson Vermont Corp. ("Jones & Lamson"), Bridgeport Machines, Inc., ("Bridgeport"), Hill-Loma, Inc., ("Hill-Loma") and Goldman Industrial Group, Inc., ("Goldman Industrial"), debtors and debtors in possession in the above-captioned Chapter 11 cases (the "Debtors"), for entry of an order (i) authorizing the sale of substantially all of the Bryant Debtor's assets free and clear of all liens, claims, interests and encumbrances pursuant to sections 363(b), (f) and (m) of the Bankruptcy Code, to BF Acquisition, LLC (the "Buyer"), if any; (ii) approving the Bid Procedures; (iii) approving the Break-Up Fee and (iv) approving the notice of the hearing on such Sale Motion. Upon review of the Sale Motion, the relief requested therein, the objections to the Sale Motion (if any), the representations adduced at the Sale Hearing and for good cause shown, the Court makes the following findings of fact and conclusions of law and enters the following orders:

¹ All capitalized terms used herein but not otherwise defined shall have those meanings set forth in the Sale Motion or the Asset Purchase Agreement, which is attached hereto as Exhibit A.

A. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, and this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2).

B. The Debtors filed petitions for relief under Chapter 11 of the Bankruptcy Code on February 14, 2002 (the "Petition Date").

C. On April 25, 2002, the Debtors filed the Original Sale Motion and on May 8, 2002, the Debtors filed the Amended Sale Motion.

D. A notice of hearing on the Amended Sale Motion in a proper and sufficient form was timely served on the Notice Parties. Certificates of service establishing the same have been filed with the Court.

E. Other parties interested in bidding on the Assets were provided sufficient information by the Debtors to make an informed judgment as to whether to bid on the Assets.

F. The following bid procedures have been established by the Debtors for the auction of the Assets:

(a) Only qualified bidders (the "Qualified Bidders") may submit an offer (for all or a portion of the Bryant Debtors' Assets and any executory contracts that such bidder designates) with respect to the Assets or otherwise participate in an auction with respect to Sale (the "Auction"). Persons or entities who propose to become Qualified Bidders ("Proposed Qualified Bidders"), on or before 5:00 p.m. eastern time on the 3rd business day prior to the date first set for the Auction (the "Bid Deadline"), must comply with each of the following requirements (a "Qualified Bid"):

(i) provide the Debtors with evidence that in the reasonable discretion of the Debtors' and Fleet Capital Corporation, as agent for the Debtors' pre- and post-petition lenders (the "Agent") establishes that the Proposed Qualified Bidder has sufficient financial ability to close and consummate a Sale (and provide adequate assurance of future performance with respect to any executory contracts designated by the Proposed Qualified Bidder to take by assignment from the Bryant Debtors) pursuant to an asset purchase agreement (substantially in form of the Asset Purchase Agreement with such modifications as are indicated thereon by the Proposed Qualified Bidder). To the extent any

Proposed Qualified Bidder is rejected by the Debtors and the Agent, information concerning the grounds for rejection of such Proposed Qualified Bidder shall be provided to counsel to the Committee subject to reasonable agreements as to the confidentiality of such information. Any bidder shall provide the Debtors and Debtors' counsel (and, subject to reasonable agreements as to the confidentiality of such information, Debtors' counsel shall provide such information to counsel to the Agent and counsel to the Committee), within twenty-four (24) hours after the Debtors' request, financial statements and other documents relating to its business activities and its ability to perform in the event that its bid is accepted (including evidence of the structure and financing of the proposed transaction (cash, notes, etc.) and including the amount of equity to be committed and sources of financing);

(ii) unless previously delivered to the Debtors, execute a confidentiality agreement in form and substance reasonably satisfactory to the Debtors prior to conducting any due diligence or obtaining information reasonably considered confidential by the Debtors;

(iii) submit an executed form of the Asset Purchase Agreement, marked to show all changes thereto on terms and conditions substantially identical to those set forth in such Asset Purchase Agreement and include with such submission (as applicable) a list of all Assets that Proposed Qualified Bidder wishes to include in its bid and a list of liabilities of the Debtors, if any, the Proposed Qualified Bidder is assuming, including but not limited to, and all executory contracts and unexpired leases that the Proposed Qualified Bidder wishes to have assumed and assigned to it;

(iv) provide for a Closing Date which is not later than the earlier of (x) May 31, 2002 (provided that the Court has waived the requirements of Bankruptcy Rule 6004 (g)) or (y) the first business day after any stay of the Sale Order expires; provided, that all conditions to Closing contained in the applicable asset purchase agreement have been satisfied or waived on such date;

(v) tender a good faith deposit in the form of a bank or certified check in the amount of 10% of the purchase price set forth in their asset purchase agreement (the "Deposit"), made payable to the Bryant Debtors, to be tendered to counsel to the Debtors (or some other agent selected by the Bankruptcy Court) as a condition to bidding. If the Proposed Qualified Bidder is the Successful Bidder(s) with respect to a Sale, the Deposit will be applied

towards the amount of the successful bid. If the Proposed Qualified Bidder is not the Successful Bidder(s); the Deposit will be held pending closing with the Successful Bidder(s); provided that in accordance with Paragraph (i) below, in the event that the Proposed Qualified Bidder becomes the Successful Bidder(s) as a result of a prior Successful Bidder(s)'s failure to consummate a Sale, the Deposit will be applied towards the amount of the successful bid. Any such Deposit tendered by any bidder that becomes a Successful Bidder(s) shall be (i) remitted to the Debtors in the event that any such Successful Bidder(s) fails to close and consummate a Sale as a result of its breach of the terms and conditions of its asset purchase agreement; or (ii) returned to any bidder in the event that (A) its bid is not a successful bid or (B) Closing is not consummated as a result of the Debtors' breach of the terms and conditions of the applicable asset purchase agreement including the failure to obtain Court authorization for a Sale; and

(vi) provide a written statement by the Proposed Qualified Bidder that (i) such bidder agrees to comply with such other terms and procedures as may be imposed by the Court or the Debtors on all potential bidders including Buyer at or prior to the Auction; (ii) the bid (as the same may be enhanced at the Auction) shall be irrevocable through Closing Date except as provided in the applicable asset purchase agreement; (iii) the bidder believes in good faith that its bid constitutes a Qualified Bid; (iv) the Deposit shall be treated in accordance with the provisions of the Amended Sale Motion; (v) the bid (as the same may be enhanced at the Auction) is not subject to any due diligence or financing conditions, and (vi) identifies which liabilities of the Debtors, if any, the Proposed Qualified Bidder is assuming under the bid including, without limitation, whether such bidder proposes to assume all or any part of the Debtors' employee benefits plan.

- (b) Except as otherwise decided in the Debtors' discretion, any competing bids must be on substantially the same terms as the Asset Purchase Agreement and shall not be on terms and conditions which are more burdensome or conditional in any material respect than the terms of the Asset Purchase Agreement. Such competing bids must disclose the identity of the competing buyer.
- (c) Any competing bids shall be in writing and filed with the Bankruptcy Court at least three (3) business days in advance of date first set for the Auction, with copies of such bids to be served on and received at least two (2) business days prior to date first set for the Auction:

- (iii) counsel to the Committee - Mike Traison, Miller, Canfield, Paddock and Stone, P.L.C., 150 West Jefferson Avenue, Suite 2500, Detroit, MI 48226 and Timothy Fusco, Miller, Canfield, Paddocks and Stone, P.L.C., 840 West Long Lake Road, Suite 200, Tray, MI 48098;
- (iv) the PBGC - Pension Benefit Guaranty Corporation, 1200 K Street N.W. 3rd Floor, Washington, D.C. 20005 attention: Andrea Wong;
- (v) the United States Trustee attention: David Buchbinder, Office of the U.S. Trustee, 844 King Street, Suite 2313, Lockbox 35, Wilmington, DE 19801 ;
- (vi) Counsel to American Capital Strategies - Brad R. Godshall, Pachulski, Stang, Ziehl, Young & Jones, 10100 Santa Monica Blvd., 11th Fl., Los Angeles, CA 90067;
- (vii) SSG - Matt Karlson, SSG Capital Advisors, Inc., Five Tower Bridge, 300 Barr Harbor Drive, Suite 420, West Conshohocken, PA 19428;
- (viii) Counsel to Regency Bank - Daniel K. Astin and Douglas M. Hershman, The Bayard Firm, 222 Delaware Avenue, Suite 900, Wilmington, DE 19801; and
- (ix) Regency Savings Bank - Edward W. Wilkowski, Assistant Vice President, Regency Savings Bank, 11 Madison Street, Oak Park, Illinois 60302.
- (d) The initial competing bid shall be, at a minimum, in an amount equal to the Purchase Price, plus \$100,000.
- (e) The auction shall be absolute with bid increments of not less than \$50,000.
- (f) Only those bids submitted by Proposed Qualified Bidders and constituting Qualified Bids will be entitled to bid at the Auction, unless the Debtors determine otherwise.
- (g) If a Qualified Bid is received, the Debtors will conduct the Auction at the offices of Debtors' counsel, Greenberg Traurig, The Brandywine

Building, 1000 West Street, Suite 1540, Wilmington, Delaware 19801, one (1) business day prior to the Sale Hearing at 1:00 p.m. Eastern Time. Bidding at the Auction will commence with the highest Qualified Bid(s) from Qualified Bidder(s) on individual Assets and will continue in the established increments until all parties have made their final offers on individual Assets. Bidding at the Auction will continue with the highest Qualified Bid(s) from Qualified Bidder(s) on discrete groups of Assets, designated by either the Debtors or any Qualified Bidder(s) prior to or at the Auction, and will continue in the established increments, until all parties have made their final offers on discrete groups of Assets. Next the Debtors will accept bidding at the Auction for a Sale, starting with the highest Qualified Bid and continuing in the established increments, until all parties have made their final offers on a Sale.

- (h) At the conclusion of the Auction, the Debtors and the Agent, after consultation with the Debtors' secured lenders and the Committee, will announce their determination as to the highest and best bid for the Assets (the "Successful Bid") by the Qualified Bidder(s) who will become the Successful Bidder(s). The Debtors reserve the right to determine which bid or combination of bids, if any, is the highest or otherwise best offer at the Auction or to withdraw this Sale Motion at any time prior to the Sale Hearing. The determination of the highest and best bid for the Assets will be made by the Debtors based on their business judgment and taking into account the value of the total consideration provided for in the offer (whether such consideration is cash or through assumption of liabilities) to the Bryant Debtors' estates; provided, that the Debtors may, in their sole discretion, give preference to cash offers even if such cash offers provide less total consideration than offers which include non-cash consideration. Formal acceptance of a winning bid, however, will not occur unless and until the Court enters an order approving the winning bid and authorizing the Debtors to consummate the Sale following the conclusion of the Sale Hearing.
- (i) Upon failure to consummate a Sale because of a breach or failure on the part of the successful bidder(s), the Debtors may select in their business judgment the next highest or otherwise best Qualified Bid(s) to be the successful bid(s) without further order of the Court.

The above Bid Procedures were reasonable and appropriate.

G. An Auction was held on May 22, 2002 at 1:00 pm for the Assets which continued on May 23, 2002 by order of this Court. At the conclusion of such Auction, Buyer was the

Successful Bidder. Buyer agreed to pay a purchase price of \$2,500,000 for the Purchased Assets (the "Purchase Price").

H. Buyer was also the Successful Bidder in the Fellows Auction.

I. There has been an adequate opportunity for all parties in interest to appear and be heard on the Amended Sale Motion. Due and adequate notice and an opportunity to be heard in accordance with all applicable law were given to all necessary parties in the Debtors' cases, including, without limitation, all federal and state environmental and taxing authorities.

J. Buyer and Regency Savings Bank have agreed upon the terms and conditions of Buyer's use and occupancy of the Fellows Real Property in accordance with the DIP Stipulation, as modified by this Order.

K. Based upon the representations tendered, for which there was no objection, the Debtors have articulated reasonable business judgment and have demonstrated good faith for seeking a prompt Sale of substantially all of the Assets. The Court finds that a prompt Sale of the Purchased Assets is required if the Bryant Debtors and their estates are to obtain any value from the Purchased Assets. Consummation of the Sale shall result in the maximization of the value of the Bryant Debtors' estates. The Court further finds that approval of the Sale is in the best interests of the Bryant Debtors' estates and their creditors and, after consideration of all salient factors, there are good and sufficient business justifications for the sale contemplated by the Amended Sale Motion, outside of the context of a plan of liquidation, and that the required standard of a "sound business purpose" has been established.

L. Based upon the representations tendered, Buyer is a good faith purchaser for value within the meaning of section 363(m) of the Bankruptcy Code and is entitled to all protections thereof. The Court finds that the sale and the negotiation of the Asset Purchase Agreement and all exhibits and schedules thereto were at arms' length and in good faith. Further, there is no evidence of the existence of an agreement among potential bidders to control the bidding process or the Purchase Price. The terms of the proposed Sale are fair, and the Purchase Price is adequate and constitutes reasonably equivalent and fair value for the Purchased Assets.

ACCORDINGLY, IT IS HEREBY ORDERED THAT:

1. The Amended Sale Motion is hereby approved in all respects. Any objections filed to the Amended Sale Motion are hereby resolved by this Sale Order.
2. The Asset Purchase Agreement is approved in its entirety. To the extent that this Sale Order conflicts with the Asset Purchase Agreement, this Sale Order shall control. For purposes of clarification, a conflict between the Asset Purchase Agreement and this Sale Order shall not exist merely due to the fact that the Asset Purchase Agreement addresses (a) any particular matter in more detail than as addressed in this Sale Order, and (b) any matter not addressed in this Sale Order.
3. The Bryant Debtors are authorized to and shall sell, assign, transfer and deliver to Buyer and Buyer shall purchase, acquire and take assignment and delivery of the Purchased Assets and to execute all documents and instruments necessary to effect the Sale.
4. Except for the Assumed Liabilities, all of Sellers' liabilities and obligations shall be retained by and remain the obligations and liabilities of Sellers and Buyer shall not assume, or be responsible or liable with respect to, any and all of the liabilities and obligations of Sellers,

whether or not relating to the Businesses, whether fixed, contingent or otherwise, and whether known or unknown, including without limitation, the following:

- (i) Any liability, claim or obligation of Sellers for any federal, state or local Taxes due and/or payable prior to or after the Closing, including (a) all income and franchise taxes of Sellers, (b) any real property taxes other than real property taxes that are part of the Regency Savings Bank Obligations (as defined in the Asset Purchase Agreement) as provided in Section 2.03(iii) of the Asset Purchase Agreement, and (c) any personal property Taxes with respect to the Purchased Assets for the period prior to Closing.
- (ii) Any liability, claim or obligation relating to, based in whole or in part on events or conditions occurring or existing in connection with, or arising out of, the Businesses as operated by Sellers prior to the Closing, including any liability or obligation in connection with any defaults or failure of performance by Sellers which have accrued or occurred prior to the Closing under or in respect of any purchase orders or sales orders or the ownership, possession, use or sale of the Purchased Assets prior to the Closing.
- (iii) Any liability, claim or obligation with respect to any litigation or legal proceeding pending on the date of the Asset Purchase Agreement, or instituted hereafter, in connection with, or arising out of, the Businesses as operated by Sellers prior to the Closing.

- (iv) Any liability, claim or obligation in connection with, or arising out of any claim or dispute for services rendered or products, systems or goods manufactured, designed, configured, engineered, assembled, compiled, distributed or sold by Sellers prior to the Closing, including, without limitation, product liability claims.
- (v) Any liability, claim or obligation in connection with, or arising out of, any claims based on harm to the environment or the disposal of hazardous materials allegedly committed by Sellers prior to the Closing, whether or not in connection with the Businesses, including the obligation to pay any and all fines, penalties, liabilities, consequential damages, whether foreseeable or unforeseeable, any other damages, costs and losses, including remedial, removal, response, abatement, clean-up, investigative and monitoring costs, and any other related costs, expenses, losses, damages and reasonable attorneys' fees arising from or in connection with
 - (a) any violation of requirements of any laws (including rules and regulations thereunder) of federal, state and local governments (and all agencies thereof) concerning the environment, public health and safety and employee health and safety, (b) environmental claims under any Environmental Law (including without limitation, Compensation and Liability Act of 1980) based on acts, omissions or occurrences prior to the Closing, and (c) any release into the environment of any hazardous materials generated by Sellers from their respective facilities.

- (vi) Any liability, claim or obligation in connection with, or arising out of, the Excluded Assets.
- (vii) Any trade accounts and other payables of Sellers due to suppliers and vendors and others of or other accounts payable.
- (viii) Any liability, claim or obligation arising from or in connection with (a) wages, benefits, bonuses or commissions due to any employee or independent contractor of Sellers, (b) contributions by Sellers under any Employee Plans (as defined below), (c) any other benefits due to or for the benefit of any employee or independent contractor of Sellers, (d) workers' compensation or other occupational health or injury claims of Sellers on or prior to the date of the Asset Purchase Agreement, (e) notices regarding plant closings, including without limitation, notices under the federal "WARN" laws, and (f) notices regarding continuation of health care coverage and rights of conversion for insured benefits.
- (ix) Any sponsorship or responsibility for the maintenance of or termination of any Employee Plan (as hereinafter defined) maintained by Sellers. For purposes of this Agreement, the term "Employee Plan" shall mean any employee benefit plans, as defined in Section 3(3) of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and any "multi-employer plan" as defined in Section 3(37) of ERISA, or any other severance, bonus, stock option, stock appreciation, stock purchase, retirement, insurance, health, welfare, vacation, severance pay, retired employee benefits, pension, profit-sharing or deferred compensation plans.

agreements or arrangements providing benefits for employees or former employees of Sellers relating to the Businesses.

- (x) Any liability, claim or obligation (including with respect to sales tax and other taxes) which Buyer may become subject to or as a result of or in connection with the failure of the parties to comply with bulk sales or bulk transfer laws.
- (xi) Any and all liabilities to any union, employees or former employees whether under any collective bargaining agreement or otherwise.

5. The Purchased Assets shall be sold, transferred, conveyed and assigned to Buyer free and clear of any and all liens, claims, interests and encumbrances of whatever type whether arising before or after the Petition Date in accordance with sections 363(b), (f) and (m) of the Bankruptcy Code pursuant to such assignments and instruments of conveyance as Buyer reasonably requests. Any and all liens, claims, interests and encumbrances (including, without limitation, any liens (including any mortgage liens on any of the Purchased Assets which are fixtures) of the Agent, ACS, the PBGC, Regency or First International Bank) shall attach to the proceeds of the sale of the Purchased Assets in the same order of priority as they existed prior to the Petition Date with respect to the Purchased Assets. This provision of the Order shall be self-executing, and notwithstanding the failure of the Debtors or any other party to execute, file or obtain releases, termination statements, consents or other instruments to consummate or implement the provisions hereof or the Asset Purchase Agreement, all liens, claims, interests and encumbrances of any kind or nature in or against the Purchased Assets transferred, sold or assigned shall be deemed released.

6. At Closing, Buyer shall pay to the Agent the Purchase Price (which Agent shall apply in accordance herewith net of the fees owed to SSG which shall be remitted directly to SSG), as set forth in the Asset Purchase Agreement, for application as provided in the DIP Stipulation. The amounts payable to Agent shall be subject to disgorgement to the extent that a party in interest holds a prior or senior lien on some or all of the Purchased Assets to the liens and security interests of the Agent in the Purchased Assets. Any such party alleging a prior lien on the Purchased Assets shall initiate an action (including any actions initiated by any party to determine whether a Purchased Asset is a fixture) in this Court by a date not later than 60 days after the date of this Order or be forever barred from asserting such prior lien. The Court may extend the time to initiate such action for good cause shown. All parties shall cooperate, reasonably at their own expense, in exchanging documents and information, and conducting physical inspections, as is necessary. Notwithstanding anything to the contrary in the DIP Stipulation or otherwise, the fact that the time period contained in the DIP Stipulation to challenge the validity, priority and extent of the Agent's lien has expired will not affect the rights of Regency or First International to assert that any Purchased Asset is a fixture.

7. Upon payment of the Purchase Price to the Agent, all persons or entities holding liens, claims, interests and encumbrances of any kind or nature with respect to the Purchased Assets transferred, sold or assigned are barred from asserting such liens, claims, interests or encumbrances of any kind or nature against Buyer or the Purchased Assets.

8. Buyer is found to be a good faith purchaser within the meaning of section 363(m) of the Bankruptcy Code and shall be entitled to the protections afforded a good faith purchaser pursuant to such section. Buyer has acted in "good faith" in connection with the Sale.

9. The Closing of the Sale of Purchased Assets shall occur no later than June 3, 2002. Such Closing may take place even if a party in interest appeals this Sale Order, so long as this Order has not been stayed.

10. As provided in the DIP Stipulation as modified by this Sale Order, any use by the Buyer of the property located at 36 Precision Drive in Springfield and Chester, Vermont (the "Fellows Real Property") is limited to a period expiring no later than December 31, 2002 except in Regency's sole discretion and shall be subject to (a) agreement by the Buyer to use the Fellows Real Property and the Purchased Assets (I) to conduct or house a business related to the assembly, repair and sale of machine tools and related parts and service, or any part thereof, and to conduct any other activities incidental thereto including, without limitation, the liquidation, moving or sale of all or a portion of the Purchased Assets and (II) in a manner consistent with the obligations of Fellows under its mortgages, dated January 29, 1998, held by Regency Savings Bank ("Regency") and First International Bank ("FIB") to keep the premises in a condition and repair consistent with the condition of the Fellows Real Property on the Closing Date and to prohibit the commission of waste and (b) maintaining whatever agreement as to commercially reasonable indemnity or other protections to which the Buyer and Regency have agreed. The Buyer shall have an obligation to remove, before expiration of the Buyer's occupancy, all of the Purchased Assets from and repair the Fellows Real Property at its own expense for damage caused by or resulting from the removal of the Purchased Assets from the Fellows Real Property that occurs after the Closing Date and to maintain the insurance and security agreed to by the Buyer and Regency.

11. The Debtors are authorized and directed to execute, deliver and carry out the terms of any and all documents and instruments that may be required by the Asset Purchase

Agreement, to undertake any action required by the Asset Purchase Agreement and to take all such other steps as may be necessary to effectuate the Asset Purchase Agreement (including any steps necessary to change the names of the Bryant Debtors).

12. This Sale Order shall be binding on and inure to the benefit of successors and assigns to the Buyer and the Debtors, including any subsequently appointed trustee.

13. The Court shall retain jurisdiction for the purpose of enforcing the provisions of the Sale Order and resolving disputes. Notwithstanding Bankruptcy Rule 6004(g) which is hereby waived by the Court, this Sale Order shall be take effect and become operative and enforceable immediately upon entry.

14. The Sale is conditioned upon:


- (a) Agreement between Fellows, the Buyer and Regency as to the terms of a lease for the Fellows Real Property, which agreement shall not be unreasonably withheld;
- (b) Agreement between the Buyer and Regency as to the terms of an indemnity agreement and to the terms of an escrow agreement, which agreement shall not be unreasonably withheld; and
- (c) Agreement between Fellows, the Buyer and Regency as to reasonable insurance coverage for the Fellows Real property.

15. The Buyer and the Bryant Debtors have agreed with Regency and First International that the removal of the equipment and machinery constituting Purchased Assets shall be done by parties with experience in the industry and maintaining commercially reasonable insurance or bonds.

16. The Buyer and Regency have agreed that, to the extent that any dispute arises under the indemnity agreement after the entry of this Sale Order, such dispute may be presented to this Court for resolution notwithstanding the finality of the Sale Order.

17. Nothing herein shall affect or impair FIB's rights under the Bankruptcy Code to protect its collateral, including but not limited to its right to move for adequate protection under Section 363 of the Bankruptcy Code or to lift the stay under Section 362 of the Bankruptcy Code. In addition, all parties shall cooperate with FIB in allowing FIB or its appraiser(s) to inspect the Fellows Real Property.

ASSET PURCHASE AGREEMENT

This Asset Purchase Agreement, dated as of May 4, 2002, is entered into among Fellows Corporation, a Delaware corporation ("Fellows") and Jones & Lamson Vermont Corp., a Delaware corporation ("J & L Vermont" and together with Fellows collectively defined as "Sellers"), and BF Acquisition, LLC, a Delaware limited liability company ("Buyer").

WITNESSETH:

WHEREAS, Sellers have previously conducted businesses which manufactured machine tools and sold replacement parts (the "Businesses");

WHEREAS, Buyer desires to purchase substantially all of the assets of the Businesses from Sellers, and Sellers desire to sell substantially all of the assets of the Businesses to Buyer, upon the terms and subject to the conditions set forth below;

WHEREAS, on February 14, 2002 ("Petition Date"), each of Sellers filed a voluntary petition for relief pursuant to Chapter 11 of The Bankruptcy Reform Act of 1978, as codified in Title 11 of the United States Code §§ 101-1330 (as amended, the "Bankruptcy Code") in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") and such cases are presently pending under Case Nos. 0210468 and 0210473 (collectively, the "Bankruptcy Proceedings");

WHEREAS, on the Petition Date, J & L Metrology Company, Inc., a Delaware corporation ("J & L Metrology"), and Bryant Grinder Corporation, a Delaware corporation ("Bryant"), J & L Metrology and Bryant being related "brother-sister" companies of Sellers, also filed voluntary petitions for relief pursuant to Chapter 11 of The Bankruptcy Reform Act of 1978, as codified in Title 11 of the Bankruptcy Code §§ 101-1330 with the Bankruptcy Court and such cases are presently pending under Case Nos. 0210469 and 0210470 (collectively, the "Related Bankruptcy Proceedings");

WHEREAS, subject to approval of the Bankruptcy Court as set forth in this Agreement, and subject to the terms and conditions set forth in this Agreement, Sellers shall sell, transfer, assign, convey and deliver the Purchased Assets (as defined below in this Agreement) to Buyer free and clear of all Liens;

NOW, THEREFORE, in consideration of the foregoing and the representations, warranties, covenants and agreements contained in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are acknowledged and accepted, the parties agree as follows:

ARTICLE 1
DEFINITIONS

1.01. Definitions. The following terms, as used in this Agreement, have the following meanings:

"**Avoidance Action**" means any and all claims and causes of action which Sellers may assert under the Bankruptcy Code, including Sellers' rights of setoff, recoupment, contribution, reimbursement, subrogation or indemnity (as those terms are defined by the non-bankruptcy law of any relevant jurisdiction) and any other direct or indirect claim of any kind whatsoever, whenever and wherever arising or asserted.

"**Affiliate**" of any Person shall mean any Person directly or indirectly controlling, controlled by, or under common control with, such Person; provided, that for the purposes of this definition, "control" (including, with correlative meanings, the terms "controlled by" and "under common control with"), as used with respect to any Person, shall mean the possession, directly or indirectly, of the power to direct or cause the direction of the management and policies of such Person, whether through the ownership of voting securities, membership or partnership interests, election or appointment of directors, by contract or otherwise.

"**Agreement**" means this Asset Purchase Agreement and all Schedules and the Exhibit attached to this Agreement, as amended, consolidated, supplemented, novated or replaced by the parties from time to time, as the same may be amended from time to time.

"**Assumed Contracts**" means those Contracts identified on **Schedule 2.01(iii)** by Buyer which shall be attached to this Agreement within 10 days of the date of this Agreement, it being understood that Buyer shall not be required to assume any Contract and that any assumption by Buyer of a Contract shall be at the sole discretion of Buyer.

"**Assumed Liabilities**" shall have the meaning given such term in **Section 2.03**.

"**Auction**" has the meaning set forth in **Section 5.05**.

"**Bankruptcy Code**" has the meaning provided in the third WHEREAS clause.

"**Bankruptcy Court**" has the meaning provided in the third WHEREAS clause.

"**Bankruptcy Proceedings**" has the meaning provided in the third WHEREAS clause.

"**Bid Procedures Order**" means an order issued by the Bankruptcy Court containing terms and conditions satisfactory to Buyer and Sellers, approving the Auction and overbid procedures with respect to the transactions contemplated in this Agreement.

"**Books and Records**" means all books of account and other financial records of the Sellers pertaining to the Businesses and all advertising materials, existing customer lists

(including, to the extent included in such lists, the names and addresses of current, past and prospective customers of the Businesses), price lists, supplier lists, drawings, designs, quality control specifications, cost analyses, flow sheets, equipment and parts lists, process sheets, instruction manuals, the telephone and facsimile numbers and telephone book listings and directories of Sellers, and other records of the Seller which relate to the Businesses or relate to the Purchased Assets.

"Breakup Fee" has the meaning set forth in Section 5.05.

"Businesses" shall have the meaning given such term in the first WHEREAS clause.

"Business Day" means any day, other than a Saturday, Sunday or a day on which banks located in New York City shall be authorized or required by law to close.

"Buyer" shall have the meaning given such term in the Preamble.

"Bryant" has the meaning provided in the fourth WHEREAS clause.

"Closing" shall have the meaning given such term in Section 2.07.

"Closing Date" means the date on or as of which the Closing occurs.

"Confidentiality Agreement" means the confidentiality letter agreement, dated as of April 22, 2002, between Buyer and SSG Capital Advisors, LP (on behalf of Sellers).

"Contracts" all commitments, contracts, leases, licenses, agreements and understandings, written or oral, relating to the Purchased Assets or the operation of the Businesses to which any of the Sellers is a party or by which it or any of its Purchased Assets are bound.

"Cure Amount" has the meaning set forth in Section 6.06.

"Deposit" has the meaning set forth in Section 2.08.

"DIP Stipulation" means that certain Amended Stipulation and Final Order (I) Authorizing Debtors to (A) Obtain Post-Petition Financing Pursuant to 11 U.S.C. §§105, 361, 364(c)(2), 364(c)(3) and 364(d)(1), And (B) Use Cash Collateral Pursuant to 11 U.S.C. §363(c)(2), (II) Modifying the Automatic Stay Pursuant to 11 U.S.C. §362, And (III) Granting Adequate Protection to Pre-Petition Secured Parties Pursuant to 11 U.S.C. §361 and 363 as amended or modified and approved by the Bankruptcy Court.

"Employee Plan" has the meaning set forth in Section 2.04.

"Environmental Law" means any federal, state or local statute, law, rule, regulation, ordinance, code, policy or rule of common law in effect and in each case as amended as of the date of this Agreement and the Closing Date, and any judicial or administrative interpretation thereof as of the date of this Agreement and the Closing Date, including any

judicial or administrative order, consent decree or judgment, relating to the environment or Hazardous Materials, including, without limitation, (i) Comprehensive Environmental Response Compensation and Liability Act of 1980, 42 U.S.C. § 9601 *et seq.*, (ii) Resource Conservation and Recovery Act, 42 U.S.C. § 6901 *et seq.*, (iii) the Federal Water Pollution Control Act, 33 U.S.C. § 1251 *et seq.*, (iv) the Oil Pollution Act of 1990, 33 U.S.C. § 2701 *et seq.*, (v) the Toxic Substances Control Act, 15 U.S.C. § 2601 *et seq.*, (vi) the Clean Air Act, 42 U.S.C. § 7401 *et seq.*, (vii) the Safe Drinking Water Act, 42 U.S.C. § 3808 *et seq.*, (viii) the Hazardous Materials Transportation Act, and (ix) any Vermont state equivalent of any of the foregoing; all as amended from time to time.

"ERISA" has the meaning set forth in Section 2.04.

"Excluded Assets" shall have the meaning given such term in Section 2.02.

"Excluded Liabilities" shall have the meaning given such term in Section 2.04.

"Fellows" shall have the meaning given such term in the Preamble.

"Fellows Real Property" shall have the meaning given such term in Section 5.06.

"Final Order" means an order or judgment entered and adopted by the Bankruptcy Court as to which (i) the time for appeal has expired and a notice of appeal has not been timely filed, or (ii) any appeal taken has been finally dismissed or determined and is not subject to further review.

"Governmental Entity" means any federal, state, county, municipal, local, foreign, international, regional, or other governmental authority or any court of competent jurisdiction, administrative agency or commission or other governmental authority, board, body or instrumentality, domestic or foreign.

"Hazardous Materials" means those substances defined or classified as hazardous or toxic substances pursuant to present or future applicable Environmental Law, as amended from time to time, including without limitation, the following (i) those materials included within the definitions of "hazardous substances", "hazardous materials", "toxic substances", or "hazardous wastes" in the Federal Water Pollution Control Act, as amended, Comprehensive Environmental Response, Compensation and Liability Act of 1980, the Hazardous Materials Transportation Act, the Toxic Substance Control Act or the Resource Conservation and Recovery Act, and (ii) those substances listed from time to time in the United States Department of Transportation's Hazardous Materials Table (49 C.F.R. § 172.101 and amendments thereto) or by the Environmental Protection Agency as hazardous substances (40 C.F.R. Part 302 or 40 C.F.R. Part 116 and amendments thereto).

"Higher and/or Better Offer" means an offer or offers approved by the Bankruptcy Court to acquire any or all of the Purchased Assets other than the offer contained in this Agreement.

"Intellectual Property Rights" means all intellectual and proprietary property of Sellers used or held for use primarily in the Businesses as it exists in any jurisdiction, in each case, to the extent owned by, licensed to (to the extent such licenses are assignable), or otherwise used or held for use by Sellers, including:

- (a) computer software and related source codes, object code, and documentation related thereto used in the Businesses;
- (b) trade secrets, including, without limitation, designs, research and development information, technical information, specifications, operating and maintenance manuals, methods, technology, engineering data and drawings, know-how, processes, proprietary data, formulae, mask words, inventions and discoveries, industrial designs and other proprietary rights, whether or not patentable or subject to copyright, mask work, or trade secret protection and whether or not confidential;
- (c) United States and foreign trademarks, service marks, trade dress, trade names, brand names, Internet domain names, websites or web pages, designs, logos, or corporate names (including, in each case, the goodwill associated therewith), whether registered or unregistered, and all registrations and applications for registration thereof, including, without limitation, all rights to the names "Fellows", "Jones & Lamson" and any derivations thereof;
- (d) United States and foreign patents, patent applications and other patent rights (including any divisions, continuations, continuations-in-part, renewals, substitutions or reissues thereof, whether or not patents are issued on any such applications and whether or not any such applications are amended, modified, withdrawn or refilled);
- (e) copyrights, including all renewals and extensions thereof, copyright registrations and applications for registration thereof, and non-registered copyrights;
- (f) to the extent transferable or assignable, all licenses, sublicenses, and other agreements or permissions related to the property described in Clause (a) to Clause (e); and
- (g) the rights to sue for, and remedies against, past, present, and future infringements thereof, and the rights of priority and protection of interests therein under applicable laws and all documentation that embodies or relates to the property described in Clause (a) to Clause (f).

"IRC" means the Internal Revenue Code of 1986, as amended from time to time, and the Treasury regulations promulgated and the rulings issued thereunder.

"J & L Metrology" has the meaning provided in the fourth WHEREAS clause.

"J & L Vermont" shall have the meaning given such term in the Preamble.

"Lien" means, with respect to any of the Purchased Assets, regardless of whether created or incurred pre- or post- Petition Date, any lien, pledge, charge, option, right of first refusal, license to a third party, lease to a third party, security agreement, security interest, encumbrance or other adverse claim, restriction, interest or limitation of any kind in respect of any of the Purchased Assets or irregularities in title thereto. For the purposes of this Agreement, without limiting the definition of a "Lien", Sellers will be deemed to own subject to a Lien any asset which Sellers have acquired or hold subject to the interest of a vendor or lessor under any conditional sale agreement, capital lease or other title retention agreement relating to such asset.

"Material Adverse Effect" means a material adverse effect on the financial condition, business, assets or results of operations of the Businesses, taken as a whole.

"Permit" means any license, permit or other similar authorization issued by a Governmental Entity necessary to the ownership of the Purchased Assets or in the conduct of the Businesses and the ownership of the Purchased Assets.

"Person" means and includes an individual, partnership, association, joint venture, corporation, limited liability company, limited liability partnership, trust, trustee, any other entity or organization and any Governmental Entity.

"Petition Date" has the meaning provided in the third WHEREAS clause.

"Purchased Assets" shall have the meaning given such term in Section 2.01.

"Purchase Price" shall have the meaning given such term in Section 2.06.

"Regency Adequate Protection Payments" means the obligations of the Sellers in the DIP Stipulation to make adequate protection payments to Regency Savings Bank.

"Regency Bank Obligations" means, collectively, (a) the agreement by the Sellers in the DIP Stipulation to make the Regency Adequate Protection Payments, (b) the agreement by the Sellers and any buyer to use and occupy the Fellows Real Property (as defined in the DIP Stipulation) in accordance with the DIP Stipulation, (c) the agreement in the DIP Stipulation that any buyer provide reasonable indemnity or other protections to Regency Savings Bank in respect of its use and occupancy of the Fellows Real Property, (d) the agreement in the DIP Stipulation that any buyer repair the premises and pay for any damage relating to the removal of equipment from the Fellows Real Property, (e) the agreement in the DIP Stipulation that any buyer maintain commercially reasonable insurance and security at the Fellows Real Property during its period of occupancy, (f) the agreement in the DIP Stipulation to provide reasonable access during ordinary business hours to the Fellows Real Property for Regency Savings Bank, and (g) the agreement in the DIP Stipulation that any buyer will timely pay all utilities and taxes during its occupancy of the Fellows Real Property.

"Related Bankruptcy Proceedings" has the meaning provided in the fourth WHEREAS clause.

"Sale Order" means an order issued by the Bankruptcy Court authorizing (i) the sale, transfer, assignment, conveyance and delivery of the Purchased Assets to Buyer (or its successors or permitted assigns) free and clear of all Liens, and (ii) the assumption by Buyer of the Assumed Contracts. The Sale Order shall contain, among others, the following provisions:

- (a) The Bankruptcy Court will retain jurisdiction for the purpose of enforcing the provisions of the Sale Order and to determine disputes;
- (b) The Sellers are authorized to proceed with the Sale pursuant to 11 U.S.C. §§ 363(b), (f) and (m) free and clear of any and all Liens;
- (c) Neither the Sellers nor creditors of the Sellers have any Liens against the Buyer or the Purchased Assets;
- (d) The Buyer has acted in "good faith" in connection with the Sale;
- (e) No competitive bids have been received which meet the Bid Procedures and which the Bankruptcy Court deems reasonable and appropriate or, if such bids have been received, Buyer shall be the successful bidder at the Auction;
- (f) The Purchase Price represents the fair value of the Purchased Assets;
- (g) The Sale is in the best interests of the Sellers' estates and their respective creditors;
- (h) Due and adequate notice and an opportunity to be heard in accordance with all applicable law were given to all necessary parties in the Sellers' Chapter 11 cases, including without limitation, all federal and state environmental and taxing authorities;
- (i) Buyer and the Sellers are authorized to close the Sale immediately upon entry of the Sale Order;
- (j) Upon failure to consummate a Sale because of a breach or failure on the part of the Buyer, the Sellers may select in their collective business judgment the next highest or otherwise best qualified bid(s) to be the successful bid(s) without further order of the Bankruptcy Court;
- (k) The Sellers are authorized to cause the proceeds of the Sale, net of SSG Capital Advisors, LP's fees which shall be paid directly to SSG Capital Advisors, LP, to be paid to the Agent to be applied in accordance with the DIP Stipulation; and

- (l) Waiving the requirements of Bankruptcy Rule 6004(g).

"Sellers" has the meaning provided therefore in the Preamble.

"Tax" or "Taxes" means all taxes, assessments, charges, duties, fees, levies or other governmental charges including, without limitation, all federal, state, local, foreign and other net or gross income, gross receipts, alternative or add-on minimum tax, franchise, profits, capital gains, capital, transfer, sales, use, *ad valorem*, occupation, premium, property, excise, severance, environmental (including taxes under IRC §59A) or windfall profits tax, stamp, license, payroll, employment, withholding and other taxes, assessments, charges, customs, duties, fees, levies or other governmental assessments or charges of any kind whatsoever (whether payable directly or by withholding and whether or not requiring the filing of a return), all estimated taxes, deficiency assessments, additions to tax, penalties and interest, whether disputed or not.

ARTICLE 2

PURCHASE AND SALE

2.01. Purchase and Sale. Except as otherwise provided below, upon the terms and subject to the conditions of this Agreement, Buyer agrees to purchase from Sellers and Sellers agree to sell, transfer, convey, assign and deliver, or cause to be sold, transferred, conveyed, assigned and delivered, to Buyer at Closing, free and clear of all Liens, all of Sellers' right, title and interest in, to and under the assets, properties and business, of every kind and description, wherever located, all personal property, tangible or intangible, owned, held or used in the conduct of the Businesses by Sellers as the same shall exist on the Closing Date, other than the Excluded Assets, including without limitation, all right, title and interest of Sellers in, to and under the following (collectively, the "Purchased Assets"):

- including any assets thereon which are fixtures*
- (i) all personal property and interests therein, including machinery, equipment, furniture, office equipment (including all computers and related hardware), communications equipment, vehicles, transportation equipment, spare and replacement parts, tools, metal working equipment, laboratory test equipment, patterns, molds, dies, jigs, fuel inventory, supplies and other tangible property, including without limitation, the items set forth on Schedule 2.01(i) which shall be attached to this Agreement within 10 days of the date of this Agreement;
 - (ii) all raw materials, work-in-process, finished goods, "crib stock", packaging materials, supplies and other inventories;
 - (iii) the Assumed Contracts as specifically set forth on Schedule 2.01(iii);
 - (iv) all prepaid expenses, including but not limited to *ad valorem* taxes, leases and rentals (except for prepaid expenses related to Contracts not assumed

by the Buyer);

- (v) all of Sellers' rights, claims, credits, causes of action or rights of set-off against third parties relating to the Purchased Assets, including, without limitation, unliquidated rights under manufacturers' and vendors warranties and rebates;
- (vi) all interests of Sellers in the Intellectual Property Rights, including without limitation, all computer software programs (including without limitation, all source codes and object codes) and data used in connection with the Businesses;
- (vii) all transferable licenses, Permits and regulatory approvals or other governmental authorizations affecting, or relating in any way to, the Businesses or the operation of the Businesses (it being understood that the Buyer may, but shall not be required to, accept and assume any of said licenses, Permits, approvals or authorizations);
- (viii) all Books and Records, files and papers, whether in hard copy or computer format, used in the Businesses, including, without limitation, any information relating to Tax imposed on the Purchased Assets; and
- (ix) all goodwill associated with the Businesses or the Purchased Assets, together with the right to represent to third parties that Buyer is the successor to the Businesses.

2.02. Excluded Assets. Notwithstanding anything to the contrary in this Agreement or otherwise, Buyer expressly understands and agrees that the following assets and properties of Sellers (the "Excluded Assets") shall be excluded from the Purchased Assets:

- (i) all of Sellers' cash and cash equivalents on hand and in banks;
- (ii) all of Sellers' real estate, including without limitation, all buildings, fixtures, and improvements erected thereon;
(except those items listed on Schedule 2.01(i))
- (iii) insurance policies;
- (iv) all Contracts other than Assumed Contracts;
- (v) the Avoidance Actions and any rights, defenses, crossclaims or counterclaims with respect to any Avoidance Actions; and
- (vi) all accounts, notes and other receivables.

2.03. Assumption of Liabilities. Upon the terms and subject to the conditions of this Agreement, Buyer agrees, effective at the time of Closing, to assume, pay, perform and

discharge the following liabilities (the "Assumed Liabilities"):

- (i) all liabilities and obligations of Sellers arising from and after the Closing Date under all Assumed Contracts, if any;
- (ii) all Cure Amounts related to any Assumed Contracts, if any; and
- (iii) the Regency Bank Obligations, provided, however, the Regency Bank Obligations shall exclude, Sellers shall retain and Buyer shall not assume, pay, perform or discharge (a) the Regency Adequate Protection Payments which shall be paid from the proceeds of the Sale, and (b) any and all real estate Taxes attributable to the Fellows Real Property for any time period other than the time period during which Buyer occupies the Fellows Real Property (e.g., Buyer shall not be responsible for the payment of any delinquent real estate Taxes attributable to the Fellows Real Property); and which will be attached at or prior to closing.
- (iv) liabilities under the purchase orders, if any, listed on Schedule 2.03(iv) which will be attached at or prior to Closing.

2.04. Excluded Liabilities. Except for the Assumed Liabilities set forth in Section 2.03, all of Sellers' liabilities and obligations shall be retained by and remain the obligations and liabilities of Sellers and Buyer shall not assume, or be responsible or liable with respect to, any and all of the liabilities and obligations of Sellers, whether or not relating to the Businesses, whether fixed, contingent or otherwise, and whether known or unknown, including without limitation, the following (collectively, the "Excluded Liabilities"):

- (i) Any liability, claim or obligation of Sellers for any federal, state or local Taxes due and/or payable prior to or after the Closing, including (a) all income and franchise taxes of Sellers, (b) any real property Taxes other than real property Taxes that are part of the Regency Savings Bank Obligations as provided in Section 2.03(iii), and (c) any personal property Taxes with respect to the Purchased Assets for the period prior to Closing.
- (ii) Any liability, claim or obligation relating to, based in whole or in part on events or conditions occurring or existing in connection with, or arising out of, the Businesses as operated by Sellers prior to the Closing, including any liability or obligation in connection with any defaults or failure of performance by Sellers which have accrued or occurred prior to the Closing under or in respect of any purchase orders or sales orders or the ownership, possession, use or sale of the Purchased Assets prior to the Closing.
- (iii) Any liability, claim or obligation with respect to any litigation or legal proceeding pending on the date of this Agreement, or instituted hereafter, in connection with, or arising out of, the Businesses as operated by Sellers

prior to the Closing.

- (iv) Any liability, claim or obligation in connection with, or arising out of any claim or dispute for services rendered or products, systems or goods manufactured, designed, configured, engineered, assembled, compiled, distributed or sold by Sellers prior to the Closing, including, without limitation, product liability claims.
- (v) Any liability, claim or obligation in connection with, or arising out of, any claims based on harm to the environment or the disposal of Hazardous Materials allegedly committed by Sellers prior to the Closing, whether or not in connection with the Businesses, including the obligation to pay any and all fines, penalties, liabilities, consequential damages, whether foreseeable or unforeseeable, any other damages, costs and losses, including remedial, removal, response, abatement, clean-up, investigative and monitoring costs, and any other related costs, expenses, losses, damages and reasonable attorneys' fees arising from or in connection with (a) any violation of requirements of any laws (including rules and regulations thereunder) of federal, state and local governments (and all agencies thereof) concerning the environment, public health and safety and employee health and safety, (b) environmental claims under any Environmental Law (including without limitation, Compensation and Liability Act of 1980) based on acts, omissions or occurrences prior to the Closing, and (c) any release into the environment of any Hazardous Materials generated by Sellers from their respective facilities.
- (vi) Any liability, claim or obligation in connection with, or arising out of, the Excluded Assets *other than as provided in Section 2.03(iii).*
- (vii) Any trade accounts and other payables of Sellers due to suppliers and vendors and others of or other accounts payable.
- (viii) Any liability, claim or obligation arising from or in connection with (a) wages, benefits, bonuses or commissions due to any employee or independent contractor of Sellers, (b) contributions by Sellers under any Employee Plans (as defined below), (c) any other benefits due to or for the benefit of any employee or independent contractor of Sellers, (d) workers' compensation or other occupational health or injury claims of Sellers on or prior to the date of this Agreement, (e) notices regarding plant closings, including without limitation, notices under the federal "WARN" laws, and (f) notices regarding continuation of health care coverage and rights of conversion for insured benefits.
- (ix) Any sponsorship or responsibility for the maintenance of or termination of any Employee Plan (as hereinafter defined) maintained by Sellers. For purposes of this Agreement, the term "Employee Plan" shall mean any

employee benefit plans, as defined in Section 3(3) of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and any "multi-employer plan" as defined in Section 3(37) of ERISA, or any other severance, bonus, stock option, stock appreciation, stock purchase, retirement, insurance, health, welfare, vacation, severance pay, retired employee benefits, pension, profit-sharing or deferred compensation plans, agreements or arrangements providing benefits for employees or former employees of Sellers relating to the Businesses.

- (x) Any liability, claim or obligation (including with respect to sales Tax and other Taxes) which Buyer may become subject to or as a result of or in connection with the failure of the parties to comply with bulk sales or bulk transfer laws.
- (xi) Any and all liabilities to any union, employees or former employees whether under any collective bargaining agreement or otherwise.

2.05. Assignment of Contracts and Rights. Subject to the approval of the Bankruptcy Court and pursuant to the Sale Order, the Assumed Contracts, if any, will be assumed by Sellers and assigned to Buyer on the Closing Date under Section 365 of the Bankruptcy Code. All Assumed Contracts shall be assigned by Sellers to, and assumed by, Buyer at Closing.

2.06. Purchase Price. In consideration for the sale of the Purchased Assets by Sellers to Buyer, Buyer agrees to pay Sellers the sum of \$3,700,000 (the "Purchase Price") by certified or official bank check payable to Sellers or by wire transfer of such funds to an account designated by Sellers acceptable to the Bankruptcy Court.

2.07. Closing. Subject to the terms and conditions of this Agreement, the sale and purchase of the Purchased Assets, the assignments of the Assumed Contracts and the assumptions of the Assumed Liabilities shall take place at a closing (the "Closing") to be held at 6200 Riverside Drive, Cleveland, Ohio 44135, or at such other location as the parties shall agree in writing, at 11:00 A.M., as soon as practicable, but in any event on the later of (i) May 31, 2002 (provided that the Court has waived the requirements of Bankruptcy Rule 6004(g)), and (ii) the first Business Day after any stay of the Sale Order expires, or at such other time or place as Buyer and Sellers may agree in writing.

If, but only if, there are Assumed Contracts, at the Closing, Sellers and Buyer shall enter into an assignment and assumption agreement with respect to the Assumed Contracts. Sellers shall deliver to Buyer (or permitted assignees as Buyer shall instruct Sellers) such bills of sale, endorsements, consents, assignments, powers of attorney (in particular with respect to Sellers' assignment of Intellectual Property Rights to Buyer) and other good and sufficient instruments of conveyance and assignment as the parties and their respective counsel shall deem reasonably necessary or appropriate to vest in Buyer all right, title and interest in, to and under the Purchased Assets being acquired by Buyer.

2.08. Deposit. At such time as Buyer has executed this Agreement and received a

countersigned signature page of this Agreement from Sellers, Buyer shall promptly pay for the benefit of Sellers a deposit in the amount of \$300,000 (the "Deposit"). The Deposit shall be wire transferred by Buyer to Greenberg Traurig, P.C. pursuant and subject to the escrow letter attached hereto as Exhibit A. At the Closing, the Deposit shall be credited against the Purchase Price; provided, however, that (a) except as provided in Clause (b) of this Section 2.08, the Deposit shall be returned to Buyer in full in the event that this Agreement is terminated, and (b) the Deposit shall be retained by Sellers in full in the event that Sellers' sale of the Purchased Assets to Buyer fails to close due to Buyer's breach of this Agreement.

ARTICLE 3

REPRESENTATIONS AND WARRANTIES OF SELLERS

Subject to the entry of the Sale Order, Sellers hereby jointly and severally represent and warrant to Buyer as follows:

3.01. Organization and Standing; Authority. Sellers are each organized, validly existing and in good standing under the laws of the State of Delaware. Subject to the approval of the Bankruptcy Court, each of Sellers has all requisite corporate power and authority to enter into this Agreement, to perform its obligations under this Agreement and to consummate the transactions contemplated by this Agreement. Subject to the approval of the Bankruptcy Court, all corporate acts and other proceedings required to be taken by Sellers to authorize the execution, delivery and performance of this Agreement and the consummation of the transactions contemplated by this Agreement have been duly and properly taken. This Agreement has been duly executed and delivered by Sellers. Upon approval by the Bankruptcy Court, this Agreement and all instruments and agreements under this Agreement to which Sellers are or become a party are (or upon execution will be) constitute the legal, valid and binding obligations of Sellers, enforceable against Sellers in accordance with its terms.

3.02. Sufficiency of, Title to and Ownership of the Purchased Assets. Sellers own and will own at all times prior to transfer of the Purchased Assets to Buyer, good and marketable title to all of the Purchased Assets free and clear of all Liens, except for Liens that, pursuant to the Sale Order, shall be released upon payment of the Purchase Price at the Closing.

3.03. Insurance. Until the Closing, Sellers shall maintain in full force all insurance related to the Purchased Assets and the Businesses that is currently in effect.

3.04. Ownership of Purchased Assets. To the best knowledge of the Sellers and except as set forth on Schedule 3.04 which shall be attached hereto within five (5) days of the date hereof, all of the inventory listed on the inventory listing dated as of March 31, 2002 and all of the equipment and other assets listed on the equipment listing for the Sellers contained in the Appraisal of Machinery and Equipment of Goldman Industrial Group, Inc. presented by Koster Industries Inc. and dated as of November 20, 2001, is located at the Sellers' place of business and is owned by the Sellers.

3.05. No Warranties. Neither Sellers nor any other Person makes any express or

implied representation or warranty on behalf of Sellers. ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE EXCLUDED FROM THE SALE AND TRANSFER OF THE PURCHASED ASSETS AND THE ASSUMED LIABILITIES.

ARTICLE 4

REPRESENTATIONS AND WARRANTIES OF BUYER

Buyer represents and warrants to Sellers as follows:

4.01. Organization and Standing: Authority. Buyer is a duly organized, validly existing and in good standing under the laws of the State of Delaware and has all powers and all material governmental licenses, authorizations, permits, consents and approvals required to carry on its business as now conducted. Buyer has all requisite power and authority to enter into this Agreement, to perform its obligations under this Agreement and to consummate the transactions contemplated by this Agreement to be consummated by Buyer. All member acts and other proceedings required to be taken by Buyer to authorize the execution, delivery and performance of this Agreement and the consummation of the transactions contemplated by this Agreement to be consummated by Buyer have been duly and properly taken. This Agreement has been duly executed and delivered by Buyer and constitutes a legal, valid and binding obligation of Buyer, enforceable against Buyer in accordance with its terms.

4.02. No Conflicts: Consents. (a) The execution and delivery of this Agreement do not and the consummation of the transactions contemplated by this Agreement to be consummated by Buyer and compliance with the terms of this Agreement to be complied with by Buyer shall not, conflict with, or result in any violation of or default (with or without notice or lapse of time, or both) under, (i) the certificate of formation or operating agreement of Buyer, (ii) any agreement or obligation to which Buyer is a party or by which any of its assets are bound, or (iii) any judgment, injunction, order, or decree, or statute, law, ordinance, rule or regulation applicable to Buyer or its assets, in each case other than such as in the aggregate would not have a material adverse effect on the ability of Buyer to consummate the transactions contemplated by this Agreement to be consummated by Buyer.

(b) No material consent, approval, license, permit, order or authorization of or registration, declaration or filing with, any Governmental Entity is required to be obtained or made by or with respect to Buyer or its Affiliates in connection with the execution, delivery and performance of this Agreement or the consummation of the transactions contemplated by this Agreement, other than (i) compliance with and filings and notifications under applicable Environmental Laws, (ii) any notices, motions, orders or approvals required by the Bankruptcy Court or the Bankruptcy Code and the rules thereunder, and (iii) those that may be required solely by reason of Sellers' participation in the transactions contemplated by this Agreement.

4.03. Actions and Proceedings, etc. There are no (a) outstanding judgments, orders, injunctions or decrees of any Governmental Entity or arbitration tribunal against Buyer or any of its Affiliates, (b) lawsuits, actions or proceedings pending or, to the knowledge of Buyer,

Agreement, from the date of this Agreement until the Closing Date. Sellers (i) will give Buyer its counsel, financial advisors, auditors and other authorized representatives access to the offices, properties, Books and Records of Sellers relating to the Businesses. (ii) will furnish to Buyer its counsel, financial advisors, auditors and other authorized representatives such financial and operating data and other information relating to the Businesses as such Persons may reasonably request, and (iii) will instruct the agents, counsel and financial advisors of Sellers to cooperate with Buyer in its investigation of the Businesses. Any investigation pursuant to this Section 5.02 shall be conducted in such manner as not to interfere unreasonably with the conduct of the Businesses of Sellers. Notwithstanding the foregoing, Buyer shall not have access to personnel records of Sellers relating to individual performance or evaluation records, medical histories or other information which in Sellers' good faith opinion is sensitive or the disclosure of which could subject Sellers to risk of liability.

5.03. Notices of Certain Events. (a) Sellers shall promptly notify Buyer of:

- (i) any notice or communication from any Person alleging that the consent of such Person is or may be required in connection with the transactions contemplated by this Agreement;
- (ii) any notice or other communication from any Governmental Entity in connection with the transactions contemplated by this Agreement;
- (iii) any actions, suits, claims, investigations or proceedings commenced or, to its knowledge threatened against, relating to or involving or otherwise affecting Sellers or the Businesses that relate to the consummation of the transactions contemplated by this Agreement; and
- (iv) the damage or destruction by fire or other casualty of any material Purchased Asset or any material part thereof or if any material Purchased Asset or any material part thereof becomes the subject of any proceeding or, to the knowledge of Sellers, threatened proceeding, for the taking thereof or any part thereof or of any right relating thereto by condemnation, eminent domain or other similar action by a Governmental Entity.

(b) Sellers shall promptly notify Buyer of, and furnish Buyer any information which Buyer may reasonably request with respect to, the occurrence to Sellers' knowledge of any event or condition or the existence to Sellers' knowledge of any fact that would cause any of the conditions to Buyer's obligations to consummate the purchase and sale of the Purchased Assets not to be fulfilled.

(c) If between the date of this Agreement and the Closing Date any of the matters referenced in Section 5.03(a)(iv) shall have occurred, then Sellers, at their option, shall either repair any damage or casualty at their expense or deliver to Buyer on the Closing Date any insurance proceeds (including without limitation, condemnation insurance proceeds), or rights to receive insurance proceeds, with respect thereto or the Purchase Price shall be reduced by such

amount.

5.04 Bankruptcy Court Approval. As soon as practicable after execution of this Agreement, Sellers shall seek Bankruptcy Court approval of a sale of the purchased Assets to Buyer pursuant to this Agreement by filing or amending the existing motion for a sale pursuant to Section 363 of the Bankruptcy Code (the "**Bid Procedures and Sale Motion**"). The Bid Procedures and Sale Motion (i) requested that the Bankruptcy Court schedule a hearing on an expedited basis to confirm the sale of the Purchased Assets to Buyer no later than May 23, 2002 (the "**Sale Hearing**"), (ii) includes a provision stating that a competing bid must exceed the Purchase Price by at least \$100,000 for the initial offer and thereafter all subsequent offers must be in increments of at least \$50,000 greater than the preceding highest offer, (iii) includes a provision stating that, at the request of the Sellers, all bidders must submit financial information to the Sellers and certain other parties at least three days prior to the hearing date set for the approval of this Agreement, and (iv) includes a provision requesting the Bankruptcy Court approve the Breakup Fee. Sellers shall use their individual and collective reasonable best efforts to obtain:

- (a) entry of the Bid Procedures Order; and
- (b) entry of the Sale Order.

5.05. Breakup Fee. Sellers acknowledges that Buyer has incurred, and will incur, substantial expense and risk in performing due diligence for the transactions contemplated by this Agreement and by entering into this Agreement. Sellers agrees that, subject to approval and entry of the Bid Procedures Order, Buyer shall be entitled to a breakup fee (the "**Breakup Fee**") in the amount of 2% of the Purchase Price (i.e., \$60,000), which shall be paid directly to Buyer from the Sale proceeds if Sellers receive a Higher and/or Better Offer from a third party or third parties for the Purchased Assets at the auction conducted in accordance with the auction procedures approved by the Bankruptcy Court (the "**Auction**"). Notwithstanding anything to the contrary contained in this Agreement, Buyer shall not be entitled to the Breakup Fee if (i) the Bankruptcy Court does not enter the Bid Procedures Order, (ii) Sellers fail to sell, transfer, assign, convey and deliver the Purchased Assets to Buyer (or its successors or permitted assigns) due to a material breach by Buyer (or its successors or permitted assigns) of this Agreement, or (iii) Buyer is in breach of this Agreement. In addition, Buyer shall also be entitled to a Breakup Fee in the event the Sale does not close because the condition set forth in Section 8.01(i) is not fulfilled because of a higher and/or better offer in the Related Bankruptcy Proceedings.

5.06. Use of Fellows' Real Property. Buyer shall have the right to use the real property and improvements located at 36 Precision Drive, North Springfield, Vermont which are owned by Fellows ("**Fellows' Real Property**") in accordance with the DIP Stipulation and subject to the Regency Bank Obligations, provided, however, Buyer shall not be required to proceed with the Closing of this Agreement unless Buyer is able to negotiate acceptable terms and conditions with Regency Savings Bank for said use of the Fellows Real Property as provided in Section 8.01(h).

5.07 Name Changes. Promptly after the Closing, each of Sellers covenant to change its corporate name by amending its respective certificate of incorporation to delete the references

to "Fellows" and "Jones & Lamson Vermont".

ARTICLE 6

COVENANTS OF BUYER

Buyer agrees that:

6.01. Confidentiality. Buyer acknowledges that the information being provided to it in connection with the purchase and sale of the Purchased Assets and the consummation of the other transactions contemplated by this Agreement is subject to the terms of the Confidentiality Agreement, the terms of which are incorporated into this Agreement by reference. Effective upon, and only upon, the Closing, the Confidentiality Agreement shall terminate.

6.02. No Additional Representations. Buyer acknowledges and agrees that, except as expressly set forth in this Agreement, none of Sellers or any other Person has made any representation or warranty, expressed or implied, with respect to (i) the transactions contemplated by this Agreement, (ii) Sellers or Sellers' assets, liabilities or businesses, or (iii) the accuracy or completeness of any information regarding Sellers furnished or made available to Buyer and its representatives.

6.03. Access to Information. On and after the Closing Date, Buyer will afford promptly to Sellers and its agents reasonable access to Sellers' former properties, books, records, employees and auditors to the extent necessary to permit Sellers to determine any matter relating to its rights and obligations hereunder or relating to the continuing administration of Sellers' Chapter 11 case, or to any period ending on or before the Closing Date; provided that any such access by Sellers shall not unreasonably interfere with the conduct of the business of Buyer. Sellers will hold, and will use its best efforts to cause its officers, directors, employees, accountants, counsel, consultants, advisors and agents to hold, in confidence, unless compelled to disclose by judicial or administrative process or by other requirements of law, all confidential documents and information concerning Buyer or the Businesses provided to it pursuant to this Section 6.03.

6.04. Assumed Contracts. In the event that there are any Assumed Contracts, Buyer shall promptly comply with and perform any obligations under the Assumed Contracts.

6.05. Cure Amounts. Buyer shall pay all amounts, as determined by the Bankruptcy Court, required under Section 365 of the Bankruptcy Code to cure any and all defaults under the Assumed Contracts, if any, and to compensate the parties to the Assumed Contracts for any actual pecuniary losses resulting from such defaults (the "Cure Amount"). For purposes of clarification, this Section 6.05 shall apply only to Assumed Contracts under which Cure Amounts exist as of the Closing.

6.07. Buyer's Cooperation. Buyer shall cooperate in providing such information and evidence as is reasonably necessary to obtain the orders of the Bankruptcy Court as described in this Agreement.

ARTICLE 7

COVENANTS OF ALL PARTIES

Buyer and Sellers agree that:

7.01. Best Efforts; Further Assurances. (a) Subject to the terms and conditions of this Agreement, Buyer and Sellers will each use their best efforts to take, or cause to be taken, all actions and to do, or cause to be done, all things necessary or desirable under applicable laws and regulations to consummate the transactions contemplated by this Agreement. Sellers and Buyer each agree to execute and deliver (both before and after the Closing and without charge to the requesting party) such other documents, certificates, agreements and other writings and to take such other actions as may be reasonably necessary in order to consummate or implement expeditiously the transactions contemplated by this Agreement and to vest in Buyer good and marketable title to the Purchased Assets.

(b) Subject to the terms and conditions of this Agreement, Buyer and Sellers will each use their best efforts to take all action and to do all things necessary, proper, or advisable to consummate and make effective the transactions contemplated by this Agreement and to obtain approval and entry of the Sale Order and the Bid Procedures Order.

7.02. Certain Filings. Sellers and Buyer shall cooperate with one another (a) in determining whether any action by or in respect of, or filing with, any Governmental Entity is required, or any actions, consents, approvals or waivers are required to be obtained from parties to any material contracts, in connection with the consummation of the transactions contemplated by this Agreement, and (b) in taking such actions or making any such filings, furnishing information required in connection therewith and seeking timely to obtain any such actions, consents, approvals or waivers.

7.03. Public Announcements. The parties agree to consult with each other before issuing any press release or making any public statement with respect to this Agreement or the transactions contemplated by this Agreement and, except as may be required by applicable law, will not issue any such press release or make any such public statement prior to such consultation.

7.04. Post-Closing Access to Books and Records. After the Closing Date, the parties agree that they will each cooperate with and make available to the other party, during normal business hours, all Books and Records, information (without substantial disruption of employment) retained and remaining in existence after the Closing Date which are necessary or useful in connection with any inquiry relating to Taxes or any audit, investigation or dispute, any

litigation or investigation or any other matter requiring any such Books and Records, information or employees for any reasonable business purpose. The party requesting any such Books and Records, information shall bear all of the out-of-pocket costs and expenses (including, without limitation, attorneys' fees, but excluding reimbursement for general overhead, salaries and employee benefits) reasonably incurred in connection with providing such Books and Records, information or employees. Sellers may require certain financial information relating to the Businesses for periods prior to the Closing Date for the purpose of filing federal, state, local and foreign Tax Returns and other governmental reports, and Buyer agrees to furnish such information to Sellers at Sellers' request and expense.

ARTICLE 8

CONDITIONS TO CLOSING

8.01. Conditions to Buyer's Obligations. The obligation of Buyer to consummate the Closing is subject to the satisfaction (or waiver by Buyer, without further notice to parties in interest or approval by the Bankruptcy Court) of the following conditions:

- (a) The representations and warranties of Sellers made in this Agreement shall be true and correct in all material respects as of the Closing Date as though made as of such time, except to the extent such representations and warranties expressly relate to an earlier date (in which case such representations and warranties shall have been true and correct in all material respects on and as of such earlier date).
- (b) Sellers shall have complied in all material respects with all of their pre-Closing covenants, including without limitation, the provisions set forth in Article 5.
- (c) No provision of any applicable statute, rule, regulation, executive order, decree, temporary restraining order, judgment, preliminary or permanent injunction or other order enacted, entered, promulgated, enforced or issued by any Governmental Entity shall be in effect that (i) prevents the sale and purchase of the Purchased Assets or any of the other transactions contemplated by this Agreement, (ii) would adversely affect or interfere with the operation of the Businesses as previously conducted after the Closing, or (iii) would require Buyer or any of its Affiliates to sell or otherwise dispose of, hold separate or otherwise divest itself of, or operate in any particular manner, any of the Purchased Assets or any of the assets, properties or business of Buyer or any of its Affiliates.
- (d) There shall not be pending or threatened by any Governmental Entity any suit, action or proceeding, (i) challenging or seeking to restrain, prohibit, alter or materially delay the sale and purchase of the Purchased Assets or any of the other transactions contemplated by this Agreement, or seeking to obtain from Buyer or any of its Affiliates in connection with the sale

and purchase of the Purchased Assets any material damages, or (ii) seeking to prohibit Buyer or any of its Affiliates from effectively controlling or operating a material portion of the Businesses or the Purchased Assets.

- (e) The Bankruptcy Court shall have issued the Bid Procedures Order (the Bid Procedures Order to include the Bankruptcy Court's approval of Breakup Fees as provided in Section 5.05) and the Bid Procedures Order shall have become a Final Order or such requirement shall have been waived.
- (f) The Bankruptcy Court shall have issued the Sale Order (the Sale Order to include the Bankruptcy Court's authorization for the Sellers to pay the Breakup Fee as provided in Section 5.05) on or prior to May ~~X~~ 2002. and the Sale Order shall not be subject to any stay. 287

- (g) Sellers shall have executed any and all documents and instruments necessary to convey good and marketable title to the Purchased Assets to Buyer.
- (h) Buyer, Sellers and Regency Savings Bank shall have agreed to all of the terms and conditions of Buyer's use of the Fellows Real Property which terms and conditions shall be acceptable to Buyer in its sole discretion.
- (i) Buyer shall have simultaneously acquired certain of the assets of J & L Metrology and Bryant in the Related Bankruptcy Proceedings pursuant to that certain Asset Purchase Agreement, dated of even date herewith, among J & L Metrology, Bryant and Buyer.

8.02. Conditions to Obligation of Sellers. The obligation of Sellers to consummate the Closing is subject to the satisfaction (or waiver by Sellers, without further notice to parties in interest or approval by the Bankruptcy Court) of the following conditions:

- (a) The representations and warranties of Buyer shall be true and correct in all material respects as of the time of the Closing as though made as of such time, except to the extent such representations and warranties expressly relate to an earlier date (in which case such representations and warranties shall have been true and correct in all material respects on and as of such earlier date). Buyer shall have performed or complied in all material respects with all obligations and covenants required by this Agreement to be performed or complied with by Buyer by the Closing Date. Buyer shall have delivered to Sellers a certificate dated the Closing Date and signed by an authorized agent of Buyer confirming the foregoing.
- (b) No provision of any applicable statute, rule, regulation, executive order, decree, temporary restraining order, judgment, preliminary or permanent injunction or other order enacted, entered, promulgated, enforced or issued

by any Governmental Entity shall be in effect that prevents the sale and purchase of the Purchased Assets or any of the transactions contemplated by this Agreement.

- (c) There shall not be pending or threatened by any Governmental Entity any suit, action or proceeding, (i) challenging or seeking to restrain, prohibit, alter or materially delay the sale and purchase of the Purchased Assets or any of the other transactions contemplated by this Agreement or seeking to obtain from Sellers in connection with the sale and purchase of the Purchased Assets any material damages.
- (d) The Bankruptcy Court shall have issued the Sale Order on or prior to May ~~X~~, 2002, and the Sale Order shall not be subject to any stay.
- (e) ^{ZB} The Bankruptcy Court shall have issued the Bid Procedures Order and the Bid Procedure Order shall have become a final order or such requirement shall have been waived.
- (f) Buyer shall have paid the Purchase Price.

8.03. Frustration of Conditions. Neither Buyer nor Sellers may rely on the failure of any condition set forth in Section 8.01 or 8.02, respectively, to be satisfied if such failure was caused by such party's failure to act in good faith or to use its reasonable efforts to cause the Closing to occur, as provided in this Agreement.

ARTICLE 9

SURVIVAL

9.01. Survival. The covenants, agreements, representations, warranties and indemnities of the parties contained in this Agreement or in any certificate or other writing delivered pursuant hereto or in connection herewith shall survive the Closing.

ARTICLE 10

TERMINATION

10.01. Grounds for Termination. This Agreement may be terminated at any time prior to the Closing:

- (i) by mutual written agreement of Sellers and Buyer;
- (ii) by either Sellers or Buyer if the Closing shall not have been consummated on or before June 3, 2002;
- (iii) by either Sellers or Buyer if there shall be any law or regulation

that makes the consummation of the transactions contemplated hereby illegal or otherwise prohibited or if consummation of the transactions contemplated hereby would violate any nonappealable final order, decree or judgment of any court or governmental body having competent jurisdiction;

- (iv) by Buyer if the Sale Order shall not have been entered on or prior to May ~~28~~, 2002; *PKP
Kane*
- (v) ²⁸ by Buyer or Sellers if any Governmental Entity shall have commenced litigation seeking to enjoin consummation of the transaction;
- (vi) by Buyer or Sellers, as the case may be, in the event that a condition to Closing has not been satisfied or waived by Buyer (under Section 8.01) or by Sellers (under Section 8.02);
- (vii) by Buyer or Sellers if the Bankruptcy Court shall have approved a sale of the Purchased Assets or Business to a Person or Persons other than Buyer;
- (viii) by Buyer if Schedule 3.04 is not acceptable to Buyer in its sole discretion.

The party desiring to terminate this Agreement pursuant to **Clauses (ii), (iii), (v), (vi) or (viii)** shall give notice of such termination to the other party prior to the Closing.

10.02. Effect of Termination. If this Agreement is terminated as permitted by Section 10.01, such termination shall be without liability of any party (or any stockholder, director, officer, employee, agent, consultant or representative of such party) to the other party to this Agreement; provided that if such termination shall result from the willful failure of any party to fulfill a condition to the performance of the obligations of another party, failure to perform a covenant of this Agreement or breach by any party to this Agreement of any representation or warranty or agreement contained in this Agreement, such failing or breaching party shall be fully liable for any and all losses incurred or suffered by the other party as a result of such failure or breach. The provisions of Sections 6.01 and 11.03 shall survive any termination of this Agreement pursuant to Section 10.01.

ARTICLE 11

MISCELLANEOUS

11.01. Notices. All notices or other communications required or permitted to be given under this Agreement shall be in writing and shall be delivered by hand, sent by confirmed fax or sent, postage prepaid, by registered, certified or express mail or reputable overnight courier service and shall be deemed given when so delivered by hand, confirmed faxed or if mailed,

three days after mailing (one Business Day in the case of express mail or overnight courier service), as follows (or to such other address or telecopy number as the applicable party shall have notified the other party in writing in accordance with this Section 11.01):

11.02. Amendments and Waivers. (a) Any provision of this Agreement may be amended or waived prior to the Closing Date if, but only if, such amendment or waiver is in writing and is signed, in the case of an amendment, by each party to this Agreement, or in the case of a waiver, by the party against whom the waiver is to be effective.

(b) No failure or delay by any party in exercising any right, power or privilege under this Agreement shall operate as a waiver thereof nor shall any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, power or privilege. The rights and remedies provided in this Agreement shall be cumulative and not exclusive of any rights or remedies provided by law.

11.03. Fees and Expenses. (a) Except as otherwise provided in this Agreement, all costs and expenses incurred in connection with this Agreement shall be paid by the party incurring such cost or expense.

(b) Sellers shall pay all fees or commissions of any investment banker, broker or finder retained by Sellers and approved by the Bankruptcy Court that has acted for Sellers in connection with this Agreement or the transactions contemplated by this Agreement.

11.04. Successors and Assigns. The provisions of this Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and assigns; *provided* that no party may assign, delegate or otherwise transfer any of its rights or obligations under this Agreement without the consent of the other party.

11.05. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Vermont, without regard to the conflicts of law rules of such State.

11.06. Counterparts; Effectiveness. This Agreement may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. This Agreement shall become effective when each party shall have received a counterpart hereof signed by the other parties.

11.07. Entire Agreement; Third Party Beneficiaries. This Agreement, the Confidentiality Agreement and the documents referred to in this Agreement and therein constitute the entire agreement between the parties with respect to the subject matter hereof and supersede all prior agreements and understandings, both written and oral, between the parties with respect to such subject matter. No representation, inducement, promise, understanding, condition or warranty not set forth in this Agreement has been made or relied upon by any party hereto. Neither this Agreement nor any provision of this Agreement is intended to confer upon any Person other than the parties any rights or remedies under this Agreement.

11.08. Bulk Sales Laws. Buyer and Sellers each waive compliance by Sellers with the provision of the "bulk sales", "bulk transfer" or similar laws of any State.

11.09. Captions. The captions in this Agreement are included for convenience of reference only and shall be ignored in the construction or interpretation of this Agreement.

11.10. Severability. If any provision of this Agreement (or any portion of this Agreement) or the application of any such provision (or any portion thereof) to any Person or circumstance shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision of this Agreement (or the remaining portion thereof) or the application of such provision to any other Persons or circumstances.

11.11. Consent to Jurisdiction. Each party irrevocably submits to the exclusive jurisdiction of (a) the Courts of the State of Vermont, (b) the United States District Court for Vermont, and (c) to the extent applicable, the United States Bankruptcy Court for the District of Delaware for the purposes of any action, suit or other proceeding arising out of or related to this Agreement, or any transaction contemplated by this Agreement but for no other purpose. Each party agrees to commence any action, suit or proceeding relating to this Agreement either in the

United States District Court for Vermont or if such suit, action or other proceeding may not be brought in such court for jurisdictional reasons, in the Courts of the State of Vermont or, to the extent applicable, the United States Bankruptcy Court for the District of Delaware. Each party further agrees that service of any process, summons, notice or document by U.S. registered mail to such party's respective address set forth above shall be effective service of process for any action, suit or proceeding in Delaware with respect to any matters to which it has submitted to jurisdiction in this Section 11.11. Each party irrevocably and unconditionally waives any objection to the laying of venue of any action, suit or proceeding arising out of this Agreement or the transactions contemplated by this Agreement in (i) the Courts of the State of Vermont, (ii) the United States District Court for Vermont, or (iii) to the extent applicable, the United States Bankruptcy Court for the District of Delaware, and each party further irrevocably and unconditionally waives and agrees not to plead or claim in any such court that any such action, suit or proceeding brought in any such court has been brought in an inconvenient forum.




