RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated February 22, 2012 by Bank of Montreal, acting as collateral agent for the Secured Creditors as defined in the Security Agreement referred to below ("*Collateral Agent*").

WITNESSETH:

WHEREAS, Collateral Agent with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603 and Federal APD Incorporated, a Michigan corporation (*the "Debtor"*), with its principal place of business and mailing address at 1415 West 22nd Street, Suite 1100, Oak Brook, Illinois 60523, are parties to a certain Trademark Collateral Agreement dated April 14, 2011 which was recorded in the United States Patent and Trademark Office on May 9, 2011 at Reel 004536, Frame 0932, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Debtor has requested that the Collateral Agent release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


The Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
