TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Trademark Security Agreement") is dated as of February 22, 2012, by and between PatientWorks Corporation, a California corporation (the "Debtor"); and NewBold Corporation, a Virginia corporation, (the "Secured Party").

The Debtor and the Secured Party are parties to that certain Security Agreement dated as of the date hereof (the "Security Agreement"). In accordance with the terms of the Security Agreement, the Debtor hereby grants to the Secured Party an absolute, unconditional, continuing, first priority security interest in and lien on all of the Debtor's right, title and interest in and to the United States trademarks and trademark application described on Schedule A attached hereto and made a part hereof, to secure the payment and performance of that certain Note Payable between Debtor and Secured Party dated February 22, 2012 and in the original principal amount of \$250,000.

Secured Party may file this Trademark Security Agreement with the Assignments Division (Trademarks) of the United States Patent and Trademark Office.


This Trademark Security Agreement may be executed in one or more counterpart copies, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement. The exchange of copies of this Trademark Security Agreement and of signature pages by facsimile or other electronic transmission shall constitute effective execution and delivery of this Trademark Security Agreement as to the parties and may be used in lieu of the original Trademark Security Agreement for all purposes. Signatures of the parties transmitted by facsimile or electronic transmission shall be deemed to be their original signatures for all purposes.


