AND WHEREAS the Duchy Solicitor as nominee of Her Majesty in exercise of the power conferred on him by the Royal Warrant under the Royal Sign Manual dated 29 February 1952 and of all other powers enabling him in that behalf has agreed with the Assignees for the Assignment of such rights and interest to and in the Trade Mark as

were vested in the Company immediately before its dissolution and are now vested in the Duchy of Lancaster

NOW THIS DEED WITNESSES as follows:-

1. In consideration of the sum of THREE THOUSAND FIVE HUNDRED POUNDS (£3,500) paid to the Duchy Solicitor receipt of which is hereby acknowledged the Duchy Solicitor as nominee of Her Majesty as aforesaid HEREBY ASSIGNS AND TRANSFERS to the Assignee ALL SUCH rights and interest (if any) to and in respect of the Trade Marks as were vested in the Company immediately before its dissolution and are now vested in the Duchy of Lancaster without the goodwill of the business connected therewith TO HOLD the same unto the Assignee absolutely

IN WITNESS whereof the Duchy Solicitor has caused his official seal to be hereunto affixed and the Assignees have executed this instrument as a Deed on the date first before written

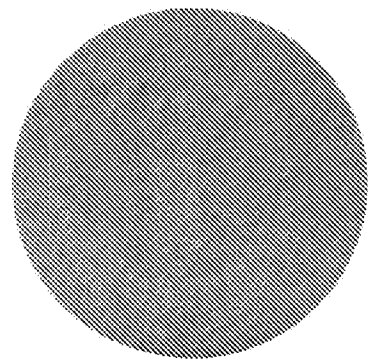
