

**RELEASE AND TERMINATION  
OF  
AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Amended and Restated Trademark Security Agreement, dated as of November 30, 2007 (the "Trademark Security Agreement"), was executed by S.S.C.I., Inc. (the "Pledgor"), covering the Trademarks more fully described on Schedule 1 annexed hereto and made a part hereof (the "Trademarks") in favor of General Electric Capital Corporation, as Collateral Agent for the Lenders party to that certain Amended and Restated Credit Agreement, dated as of November 30, 2007 (as amended, supplemented or otherwise modified to date) (in such capacity as Collateral Agent, the "Secured Party") and was recorded on August 18, 2009 with the United States Patent and Trademark Office at Reel 4046, Frame 0115. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Pledgor has requested and the Secured Party has agreed to release the Trademarks and discharge the Trademark Security Agreement.


