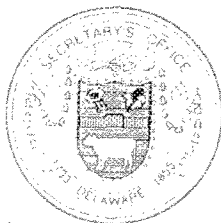

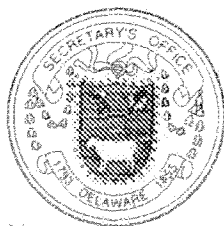

1.
