ASSIGNMENT OF TRADEMARK

This ASSIGNMENT OF TRADEMARKS ("Assignment of Trademarks") is made and entered into this 8 day of ^{March} February, 2012, by and between Care First Animal Hospital, PLLC., a Limited Liability Company of North Carolina, with an office at 1216 Oberlin Road, Raleigh, North Carolina 27608, and CareFirst of Maryland, Inc., a Maryland corporation ("Assignee"), pursuant to the terms and provisions of the Settlement Agreement, dated as of MARCH 8, 2012, by and among Assignor and Assignee.

WHEREAS, pursuant the Settlement Agreement, Assignor has agreed to assign the U.S. Trademark Application Serial No. 77/707599 for the mark CAREFIRST ANIMAL HOSPITAL (the "Trademark"), identified in attached Schedule A, to Assignee, and Assignee has agreed to accept such assignment;

NOW, THEREFORE, pursuant to the Settlement Agreement and in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademark, together with the goodwill appurtenant thereto and the entire right, title and interest in and to any equity arising out of past, present or future infringement of the Trademark.

2. Settlement Agreement. This Assignment of Trademark is subject in all respects to the terms and conditions of the Settlement Agreement, and nothing contained herein shall be deemed to supersede any of the covenants, agreements, representations or warranties of Assignor or Assignee contained in the Settlement Agreement.

3. Counterparts. This Assignment of Trademark may be executed in several counterparts, each of which shall be deemed an original, but such counterparts shall together constitute but one and the same Assignment of Trademark. This Assignment of Trademark may be executed and delivered in counterpart signature pages executed and delivered via facsimile transmission, and any such counterpart executed and delivered via facsimile transmission shall be deemed an original for all intents and purposes.


4. Benefit. This Assignment of Trademark shall bind and inure to the benefit of the parties hereto and their respective permitted successors and assigns.


