ATTACHMENT 2

TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of this January 16, 2012 (the "Effective Date"), by and among Century Boat Company, Inc., a Florida corporation, located at 6725 Bayline Drive, Panama City, Florida 32404 (the "Assignor") and All Craft Marine, LLC, a Limited Liability Corporation, located at 15020 Dawson Drive, Dade City, Florida 33523 (the "Assignee").

A. Assignor and Assignee are parties to that certain Bill of Sale dated as of January 16, 2012 (the "Agreement"); and

B. Pursuant to the Agreement, Assignee is acquiring certain assets from Assignor, including certain of Assignor's right, title and interest in and to certain trademarks and trade names and the related goodwill, ("Marks"), copyrights, related materials and the domain name which are owned by and exclusively used by Assignor being sold to Assignee under the Agreement, including the issued United States trademark registrations and domain name including the rights set forth on Schedule A attached hereto and including all Federal, State, and foreign registrations of the same heretofore granted or applied for, any and all common law rights to such Marks in the United States, any state thereof, and in foreign countries ("Century Marks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Century Intellectual Property for the United States and all foreign countries, including, without limitation, any registrations and applications related to the Marks therefor, any renewals and extensions of the registrations, all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, together with the goodwill of the business symbolized by the various Marks, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Century Intellectual Property, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representatives.

Assignor does hereby expressly agree that procedures be taken with the United States Patent and Trademark Office and with the comparable entities in foreign countries singly by Assignee to record the transfer of the Marks to Assignee and authorizes and requests the Commissioner of Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as assignee and owner of the Marks.

Assignor further assures Assignee that upon reasonable request by Assignee, it shall from time to time execute and deliver any and all further documents and writings and perform such

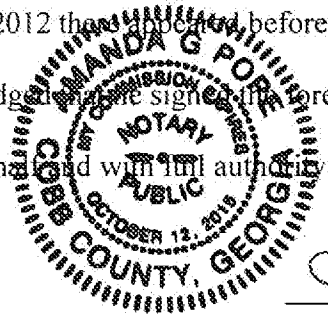

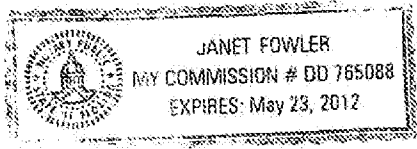
