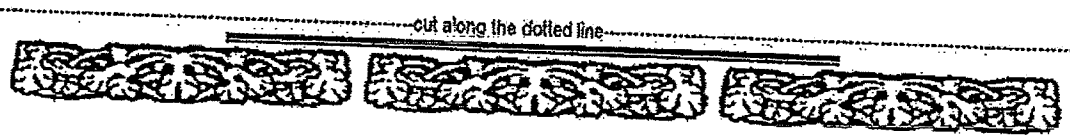

Diversified Alarm, Inc.**


James H. Smythe, who is President, and, George F. Sprenger, who is the Secretary of the above named Ohio corporation for profit, do hereby certify that:
