## TRADEMARK ASSIGNMENT

BETWEEN: Sucampo Pharmaceuticals, Inc., a corporation organized and existing under the laws of Delaware, whose address is 4520 East West Highway, Suite 300, Bethesda, Maryland 20814, U.S.A. (hereinafter "Assignor");

AND: Sucampo AG, a corporation organized and existing under the laws of Switzerland, whose address is 2<sup>nd</sup> Floor, Baarerstrasse 14-16, CH-6300 Zug, Switzerland (hereinafter "Assignee").

### WHEREAS:

- (a) Assignor is the owner of the SUCAMPO trademark, trade name and service mark within countries on the continents of Africa, Asia, Australia and Europe (the "Territory") and the related registrations and applications set forth on Schedule 1 hereto (hereinafter the "Trademarks");
- (b) Assignor and Assignee desire to have Assignee own, manage and maintain the Trademarks and therefore have agreed that the Trademarks shall be assigned to Assignee; and
- (c) Assignee, by a separate agreement, shall license Assignor and certain related companies the right to use the Trademarks.

### NOW, THEREFORE, IT IS HEREBY AGREED AND DECLARED AS FOLLOWS:

For a payment of \_\_\_\_\_ U.S. dollars, the receipt by Assignor of which is hereby mutually acknowledged, Assignor hereby assigns to Assignee all of the Assignor's right, title, and interest in and to the Trademarks, with the goodwill of the business together with the right to take action to recover damages and claim all other relief for any past infringement or passing off related to the Trademarks.


Assignor and Assignee agree that Assignee shall have the right to apply for registrations of the Trademarks throughout the world.

Assignor shall, at Assignee's request after the effective date hereof, acknowledge and deliver all such further documents, instruments, filings and other agreements and provide such other assurances and may be needed to further effectuate and confirm this Assignment. In the event Assignee is unable after reasonable efforts to secure the signature of an appropriately authorized officer or agent of Assignor, Assignor irrevocable appoints Assignee and its duly authorized officers and agents as Assignor's agent and attorney in fact to act for and on Assignor's behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this Assignment with the same legal force and effect as if executed by Assignor.

The effective date of this assignment is September 30, 2011.


