**RELEASE OF
GRANT OF SECURITY INTEREST
IN TRADEMARKS**


THIS RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS is made as of April 13, 2012, by Administrative Agent (as defined below) in favor of Havco Wood Products LLC (the "Pledgor").

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of August 8, 2005, in favor of Ares Capital Corporation (successor by merger to Allied Capital Corporation), as the Administrative Agent (the "Administrative Agent"), and pursuant thereto the Pledgor agreed with the Administrative Agent to execute and deliver a grant of security interest in trademarks, dated August 8, 2005 (the "Trademark Security Agreement") as recorded in the United States Patent and Trademark Office in Reel 3172, Frame 0588 on August 10, 2005, pursuant to which Pledgor granted to the Administrative Agent, according to the terms of the Security Agreement, a continuing security interest in and continuing lien upon the trademark applications and registrations listed on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, the indebtedness secured by the security interest in and to the Trademarks has been satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and relinquish its continuing security interest in and continuing lien upon the Trademarks, authorizes and requests the Commissioner for Trademarks at the United States Patent & Trademark Office to note and record the existence of the Release hereby given, and agrees that the filing of the Trademark Security Agreement in the United States Patent and Trademark Office as aforesaid may be removed of record.
