RELEASE OF SECURITY INTEREST

WHEREAS, Pipe Liners, Inc., ("Grantor"), Polypipe, Inc., PolyPipe Holdings, Inc., the lenders party thereto, and JPMorgan Chase Bank, N.A. ("Secured Party") entered into that certain Trademark Security Agreement ("Security Agreement") dated January 25, 2007;

WHEREAS, pursuant to that Security Agreement, Grantor, granted to Secured Party a security interest in substantially all the assets of Grantor including all right, title and interest of Grantor in, to and under all then owned and thereafter acquired Trademarks (as defined in the Security Agreement), Trademark Registrations, Trademark applications and Licenses (as defined in the Security Agreement), together with the goodwill of the business symbolized by Grantor's Trademarks, and all proceeds thereof;

WHEREAS, the Secured Party's interest in Grantor's Trademarks was recorded with the United States Patent and Trademark Office at the reel/frame numbers identified on Schedule 1 annexed hereto; and

WHEREAS, Grantor assigned the entire right title and interest in and to the Trademarks to Polypipe, Inc., a Texas corporation as recorded in the U.S. Patent and Trademark Office at reel/frame no. 4095/0634;

WHEREAS, Secured Party desires to (i) release its security interest in PolyPipe, Inc.'s Trademarks; (ii) waive all of its right, title and interest in and to PolyPipe, Inc.'s Trademarks, and restore all such right, title and interest to PolyPipe, Inc.'s Trademarks; and (iii) dissolve any and all of its liens and encumbrances respecting PolyPipe, Inc.'s Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party does hereby release its security interest in PolyPipe, Inc.'s Trademarks, and discharges, quit claims and relinquishes to PolyPipe, Inc., any and all right, title and interest it has in and to PolyPipe, Inc.'s Trademarks including but not limited to those recorded as referenced on Schedule A;
