TRADEMARK ASSIGNMENT

Assignor hereby represents, warrants and covenants that it owns all right, title and interest in and to the Trademarks, that it has the full power and authority to convey all right, title, and interest in and to the Trademarks to Assignee, that it has not executed and will not execute any agreement in conflict herewith, and that it will execute any and all other instruments which may be necessary to perfect and evidence Assignee's ownership of the property and rights herein conveyed.

The Parties agree that this Assignment constitutes the entire agreement between Assignor and Assignee with respect to the subject matter hereof. The Parties also agree that no modification or waiver of any amendment to any provision of this Assignment shall be binding upon either party unless it is made in writing and signed by both Parties.

This Assignment may be signed in counterparts, each of which shall be deemed an original but all of which shall together constitute one instrument.
