**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARKS AND PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**, dated as of May 8, 2012 ("Release"), is made by LBC CREDIT PARTNERS, L.P., in its capacity as Agent for Lenders ("Agent") in favor of BRENNER TANK LLC, a Wisconsin limited liability company ("Brenner Tank") and BRENNER TANK SERVICES LLC, a Wisconsin limited liability company ("Brenner Services") and together with Brenner Tank each a "Grantor" and collectively "Grantors").

WHEREAS, pursuant to that certain Second Amended and Restated Second Lien Loan and Security Agreement dated as of December 19, 2007 by and among the Borrowers named therein (the "Borrowers"), the Persons named therein as Credit Parties, Agent and the Persons signatory thereto from time to time as Lenders (including all exhibits and schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified, the "Loan Agreement"), Lenders have agreed to make the Loans for the benefit of Borrowers and guaranteed by Grantors;

WHEREAS, pursuant to the Loan Agreement, Grantors were required to execute and deliver to Agent, for itself and the ratable benefit of Lenders, the Second Lien Intellectual Property Security Agreement dated as of June 19, 2007 (as amended from time to time, the "IP Security Agreement");

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on June 21, 2007 at Reel 019464 Frame 0562 and Reel 3565 Frame 0227.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent (for itself and on behalf of the Lenders) and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement or the IP Security Agreement.

SECTION 2. Termination and Release. Agent, for itself and on behalf of Lenders, hereby:

(a) terminates the IP Security Agreement, the Loan Agreement, and any other agreement under which each Grantor has granted a collateral pledge, grant, assignment, lien, or security interest in, to, and under the Patent Collateral listed on Schedule A (the "Patent Collateral") and the Trademark Collateral listed on Schedule B (the "Trademark Collateral," and together with the Patent Collateral, collectively, the "IP Collateral");

(b) releases the lien on and security interest in and to the right, title, and interest in, to, and under the IP Collateral; and

(c) authorizes the recordation of this Release with the USPTO.
