Assignment of Trademark

NOW, THEREFORE, for good and valuable consideration, sufficiency and receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all right, title and interest throughout the world in and to said marks, together with the goodwill of the business in connection with which said marks are used and which is symbolized by said marks, along with the rights to police, monitor and enforce said marks against any and all past infringements, and to sue for and recover damages and profits for past infringements thereof, together with any and all further privileges throughout the world to establish use, ownership, and/or registration thereof.

Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title, and interest in and to said marks in the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.

Assignor agrees to perform all affirmative acts which may be necessary or desirable to perfect the above-described transfer of trademarks, service marks, and trade name rights, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to said marks, at Assignee's expense.
