UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, Revel accepted such assignment by Aviva of its rights, title and interests in and to the Trademarks, together with any goodwill associated with the Trademarks and the business to which the Trademarks pertain; and

WHEREAS, this Assignment is being executed to confirm such assignment of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Aviva does hereby confirm having sold, assigned, and transferred to Revel all of its rights, title, and interests in and to the Trademarks, together with any goodwill associated with the Trademarks and the business to which the Trademarks pertain. Aviva agrees, at the request of Revel, to execute and have executed any and all other documents of any kind whatsoever, and to provide any information that is in Aviva's possession or under its control that may be reasonably required to carry out the terms and intent of this Assignment; and to fully cooperate with Revel, as reasonably required, to enable Revel to duly record this Assignment with the United States Patent and Trademark Office so that Revel's ownership of the registered Trademarks is duly made of record in the United States. This Assignment shall in all respects be subject to the terms and conditions of the APA.

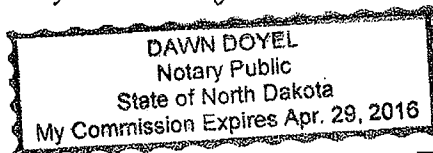
