## ASSIGNMENT AGREEMENT

This ASSIGNMENT AGREEMENT ("Agreement"), effective as of June 12, 2012, is made and entered into by and among New Aurora Corporation, a Delaware corporation, having a place of business at 22000 AOL Way, Dulles, VA 20166, ("Assignor") and AOL Inc., a Delaware corporation, having a place of business at 22000 AOL Way, Dulles, VA 20166 ("Assignee").

### RECITALS

A. Assignor was formerly known as Netscape Communications Corporation but changed its name to New Aurora Corporation, effective as of March 15, 2012.

B. Assignor adopted and owns various names and marks and has registered or sought to register the same, which applications and registrations are listed on Schedule A attached hereto, (hereinafter the "Marks");

C. Assignee desires to acquire all right, title and interest in and to the Marks, including the applications and registrations as set forth on Schedule A as well as the goodwill of the business symbolized and associated with the Marks;

NOW THEREFORE, in consideration of the sum of \$10.00 made available from Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, conveys, and delivers to the Assignee all right, title, and interest in and to the Marks, including without limitation (i) all applications and registrations for the Marks, (ii) all rights in the Marks provided by international conventions or treaties, (iii) any and all goodwill of the business symbolized by each of the Marks, (iv) all renewals and extensions of registrations thereof that may be secured under the laws of any jurisdiction, and (v) any and all rights to sue or recover and retain damages and costs and attorneys' fees for past, present, and future infringement, dilution, misappropriation, or other violation thereof, and rights of priority and protection of interests therein under the laws of any jurisdiction effective as of June 12, 2012.

2. At the request of Assignee, Assignor shall execute and deliver such documents or take such other actions as may be reasonably necessary to effectuate the purposes of this Agreement.



