## ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

KNOW ALL BY THESE PRESENTS:

THAT, BURDALE CAPITAL FINANCE, INC. ("Burdale"), in its capacity as Agent (the "Assigning Secured Party") under a Trademark Collateral Assignment and Security Agreement, dated as of August 3, 2010, executed by and between MAG IAS, LLC (formerly known as MAG INDUSTRIAL AUTOMATION SYSTEMS, LLC), a Delaware limited liability company (the "Grantor"), and the Assigning Secured Party, and recorded with the United States Patent and Trademark Office on August 10, 2010, at Reel 004262, at Frame 0301 (the "Security Agreement"), and covering trademarks, service marks, trademark registrations and applications therefor, including any good will associated therewith, and all other "Collateral", as such quoted term is defined and described in the Security Agreement, including, without limitation, those trademarks identified on the Schedule A attached hereto, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, hereby ASSIGNS AND TRANSFERS TO WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, having an office at 150 South Wacker Drive, Suite 2200, Chicago, Illinois 60606 ("Wells Fargo"), as assignee of and successor in interest to Burdale under the Loan Agreement referred to in the Security Agreement, and as successor agent for the Lenders under the Loan Agreement (Wells Fargo, in such capacities, being referred to herein as the "Assignee Secured Party"), all of the Assigning Secured Party's right, title and interest in and to (a) the Security Agreement and (b) all security interests and liens in the Collateral held by the Assigning Secured Party securing any indebtedness of the Grantor under the Loan Agreement and the Security Agreement.

Upon execution and delivery hereof, the Assignee Secured Party constitutes both the "Agent" under the Security Agreement for all purposes thereof and the holder of all security interests and liens in the Collateral originally granted by the Grantor to the Assigning Secured Party pursuant to the Security Agreement, including, without limitation, those trademarks identified on the Schedule A attached hereto.
