RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY
(TRADEMARKS)

This RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (this "Release") is made as of July 17, 2012, by HSBC Bank plc, as Security Trustee ("Security Trustee") for each of the Secured Parties, in favor of Markit On Demand, Inc. (formerly known as Wall Street on Demand, Inc.), a Delaware corporation ("Grantor"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Security Agreement, dated as of December 23, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among, *inter alios*, Grantor and the Security Trustee.

WHEREAS reference is made to the Multicurrency Revolving Facility Agreement, dated 23 December 2009 (as amended and restated on 26 March 2012 and as otherwise amended, supplemented, or modified prior to the date hereof, the "Credit Agreement"), among, *inter alios*, the Grantor, the Lenders (as defined therein) and the Security Trustee;

WHEREAS, pursuant to (i) the Security Agreement and (ii) a Trademark Security Agreement Supplement dated as of December 6, 2010 (as amended, supplemented or otherwise modified from time to time, the "IP Security Agreement"), Grantor has granted to Security Trustee, for the benefit of the Secured Parties, a security interest in and to all of such Grantor's right, title and interest in and to the Trademark Collateral (as defined in the IP Security Agreement), including registered patents and patent applications set forth on Schedule A attached hereto (the "Released IP") to secure the prompt and complete payment and performance of the obligations of the Secured Obligations; and


WHEREAS the IP Security Agreement was recorded on December 8, 2010 with the United States Patent and Trademark Office under Real and Frame number 4427/0680;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Trustee agrees as follows:

- (a) Security Trustee, on behalf of the Secured Parties, hereby relinquishes, releases, discharges and assigns to Grantor its security interest and lien in, to and under the Released IP.
- (b) Security Trustee hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.
