ASSIGNMENT OF SERVICE MARK

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all of Assignor's right, title and interest in and to the Mark, including all common-law rights, in the United States and in all other countries and jurisdictions of the world, together with the Registration, that portion of Assignor's business to which the Mark pertains, and that portion of the goodwill of Assignor's business symbolized by the Mark. Upon Assignee's request, Assignor agrees that it will, without demanding further consideration therefor and at Assignee's cost, perform all reasonable, lawful, and just acts that may be necessary for carrying out this Assignment in full.
